Oral Ouestions

Mr. Crosbie: Feeble applause.

Mr. Speyer: Mr. Speaker, Mr. MacDonald is being used as a sacrificial lamb. He is the one the Liberals have assigned to carry the can for the irresponsibility of the Minister.

Some Hon. Members: Hear, hear!

MINISTER'S POSITION

Mr. Chris Speyer (Cambridge): Mr. Speaker, does the Minister of National Revenue have any intention whatsoever, because ministerial responsibility is assigned to him, of tendering his resignation?

Right Hon. P. E. Trudeau (Prime Minister): Mr. Speaker—

FARLINGER STUDY

Mr. Chris Speyer (Cambridge): Mr. Speaker, I have another question for the Minister of National Revenue. Over two months ago Mr. Farlinger was assigned the task of looking into the administration of Revenue Canada. He was to report to the Minister on an interim basis on what he found.

Some Hon. Members: Hear, hear!

SUGGESTED APPOINTMENT OF OMBUDSMAN

Mr. John McDermid (Brampton-Georgetown): Mr. Speaker, my question is also addressed to the Minister of National Revenue. The Minister appointed Mr. Farlinger to investigate the Department. The Prime Minister fired the Deputy Minister as he just stated. The Department is now putting cute little ads in the paper to try to appear to be helpful. It is the first time the Department has done so in six years.

Mr. Nielsen: At a cost of \$300,000.
