Hon. Martin P. O'Connell (Minister of Labour): Mr. Speaker, I have not yet personally seen that telegram. I could reiterate that there is a procedure available to both parties, jointly or singly, to have this dispute between them settled. That procedure is laid out in the Labour Code and is provided for in the collective agreement which was signed six or eight weeks ago.

QUEBEC—LONGSHOREMEN'S STRIKE—POLICY RESPECTING PREVENTIVE MEDIATION—SUGGESTED INTERVENTION BY MINISTER

Mr. Lincoln M. Alexander (Hamilton West): Mr. Speaker, I wish to direct a supplementary question to the minister. In view of the fact that the situation is reaching chronic proportions, in view of the fact that the public interest is now being adversely affected, and in view of the fact that the minister's predecessor started preventive mediation, is this still the present minister's policy, and can he assure the House that in view of the catastrophic disturbance now going on he will attend on the parties personally and use his personal influence in order to get these people back to the bargaining table?

Hon. Martin P. O'Connell (Minister of Labour): Mr. Speaker, I want to assure hon. members that it is our intention to continue and to reinforce and expand preventive mediation. I might point out that it was that very process which brought this model agreement into being which is now in such jeopardy. I want to reiterate that the procedure is there to be used, and that the two parties should make use of it. Mediation at this point simply takes them off the hook for failing to use the procedures they both agreed to use.

Mr. Alexander: In view of the fact that the minister does not believe that the public interest is being adversely affected yet—

Mr. Speaker: Order, please. The hon. member knows that he cannot make that kind of statement. He was recognized again for the purpose of asking a supplementary question, but it seems to me that the preliminary statement is debate. I suggest to the hon. member that this is not procedurally correct. He can ask a supplementary question, of course.

Mr. Alexander: I accept your admonition, Mr. Speaker. May I ask the Minister of Labour whether he is in receipt of a telegram from the employers dated around May 15 seeking arbitration and also seeking permission to prosecute under the law for violation of the terms of the agreement? If so, what has he done about it?

Mr. O'Connell: Mr. Speaker, I did receive such a telegram but to the best of my memory it did not seek arbitration. Arbitration can be sought without asking the minister to provide it. The procedures are already there and both parties can agree to it. Arbitrators are designated in

the agreement, they are available and they ought to be used. With respect to the second question on consent to prosecute, we have looked into that and declined because procedures are available other than prosecution which would not do the job.
