Hon. Flora MacDonald (Minister of Employment and Immigration): Mr. Speaker, I realize the Hon. Member begins her question the way she does because of the envy of Members in that Party who want to sing in harmony. They have not been able to do that within their own group for some time.

Some Hon. Members: Oh, oh!

Some Hon. Members: Hear, hear!

Miss MacDonald: I would like to say that the main emphasis of this Government has been in the area of jobs, job creation, and in trying to bring more emphasis in that field. Although it has not been raised often by members of the Opposition, I think it is important to note that in the last month when the employment figures came down, it was shown for the first time since the recession had begun that between the months of January and February both the unemployment rate and the actual figures for unemployment had declined. This was the first time that that had taken place between the months of January and February since the recession began, and I think that is an important sign.
