MINING EXPLORATION

Mr. Guy Saint-Julien (Abitibi): Mr. Speaker, I am one of the members who worked to set up the Canadian Exploration Incentive Program in 1987–88. On December 11, 1989, I said in this House: "The CEIP expires on December 31, 1990, and today I am worried about the survival of this program."

Yesterday, we learned in the Budget that this program was cancelled as of midnight February 19, 1990. We lose the contribution equal to 30 per cent of the cost of mining, oil and gas exploration financed by flow-through shares.

Mr. Speaker, I would like to make it clear that we are maintaining the resource deduction. Flow-through shares will continue to help mining companies that are starting up to attract investors. The tax system for expenditures makes it possible to recover all pre-production costs before a new mine starts to pay tax, and I am really disappointed about losing this program.

THE BUDGET

Mr. Fred J. Mifflin (Bonavista—Trinity—Conception): Mr. Speaker, a most distasteful measure in the Wilson budget yesterday was the so-called management initiative to take away \$35 million from Canadian veterans.

Five thousand of them under chronic care will have to pay \$3,000 each, and a total of \$17.3 million for their care as part of what the government euphemistically calls updating the lodging program.

In another initiative, 60,000 living at home will lose help provided for heavy housecleaning because of an \$18 million cut for this key program to aging veterans to which the government refers as streamlining.

This government action flies in the face of a Remembrance Day statement by the Minister of Veterans Affairs which he opened by emphasizing "just how much is owed to those who did their duty for their country in war". Is this another sacred trust gone astray?

This is not what I call a management initiative. It is a shameful and disgraceful way to shift the burden of deficit reduction on the backs of those who can least afford it, and in this case, most specifically on the backs of those who have already more than paid their dues.

Veterans deserve better. They will fight back once again.
