Seven of the eight indicted are affected. Chick Gandil, the eighth, is not playing this year. The suspension practically kills all hope of the White Sox winning the American League pennant this year. While the grand jurors delivered their true bills, the Old Roman, seated in the midst of his crumbling empire out at White Sox Park, issued the telegram suspending those involved. in the midst of his crumbling empire out at White Sox Park, issued the telegram suspending those involved, paid off Weaver, Cicotte and Jackson on the spot, and announced that checks for pay due the others would be sent them at once. With his voice trembling, Mr. Comiskey, who has owned the White Sox since the inception of the American League, said this was the first time scandal had ever touched his "family" and that it distressed him too much to talk about it. The rush of players to bare their part in the affair started today, when Cicotte appeared at the criminal court building and asked permission to testify. Cicotte wept, court attaches said, and exclaimed in anguish his sorrow for his two small children as he told how he did his utmost to lose rather than win the 1919 world's series after he had "found" \$10,000 beneath his pillow, where it had been placed by professional gamblers.

He said he lobbed the ball to the plate so slowly "you could read the trademark on it" in the first game at Cincinnati, when he was taken out of the box after three and two-thirds innings had been played.

How Cicotte Did It.

Last year's world series records show that in the first inning of the first game Cicotte started by hitting Rath, the first Cincinnati batter, in the back. "We all talked quite a while about it. Yes, all of us decided to do our best to throw the games to Cincinnati. Then Gandil and McMullin took us all, one by one, away from the others, and we talked turkey. They asked me my price. I told them \$10,000 paid in advance.

"It was Gandil I was talking to. He wanted to give me some money at the time, and the rest after the games were played and lost.
