WORST SESSION, SAYS MAGISTRATE

Declares This Morning Disgraceful—Auto and Liquor Case.

"The most disgraceful morning since my appointment," was the way that Magistrate Henderson termed the proceedings in the Police Court this morning after he had disposed of a large array of prisoners presented to him at the opening of the session.

Two of those charged with drunkenness forfeited deposits of \$38 each, six others were fined \$8 or two months in jail, and a \$100 fine was struck in the liquor case, making the total of the assessments \$264.

This morning's exhibition, the magistrate said, was a display of bad citizenship, and it was a very sad thing to have so many people appearing in the court after Sunday.

"This automobile business will have to be stopped," he said, referring to a case in which Cecil Harry Wiegans was charged with having liquor in his possession other than his private dwelling.

K. J. MacRae appeared for the prisoner, who first pleaded not guilty, and, after consultation with his lawyer, changed the plea to one of guilty.

The accused explained to the court that he was hired by two men, and that the liquor must have been brought into the car by them, as he did not know how it got there. He said that he did not drink himself.

The magistrate struck a fine of \$100. The two men who were in the car, J. E. Zyles and Thos. White, failed to appear and forfeited deposits of \$38 each.

Irene Craigie, 20, and Violet La Crosse, both of Quebec, who were arrested in the car, were taken to the police station for investigation, but on their undertaking to return to their homes immediately were given their freedom.

Refused Move. Albert Phillips, charged with refusing to move when ordered to do so by the police, pleaded not guilty. The prisoner, who had stopped to talk to a friend and to light a cigarette.

Detective Saunders testified that he heard the accused on Saturday night about 11:30 calling after two young ladies who were crossing the street at the corner of Union and Charlotte. He ordered him three times to move on, and said that on the last occasion he told "if you don't move, you'll be in the hospital."

The detective said, was in the habit of passing remarks to women and girls in the street, and that he had seen Phillips in the company of a woman named Phillips.

Phillips was remanded for three days, as he desired to get with a fine of \$8.

WANT ROCK FROM PARTRIDGE ISLAND

Requested for Breakwater Extension—New Auto for Fire Chief.

The City Council had a variety of matters up for consideration this morning. Among them was a request from the Public Works Department of Canada for permission to take rock from Partridge Island for use in the extension of the breakwater; the matter of a new car for the chief of the fire department, the Lewis Boulevard and repairs to public wharves.

Commissioner Thornton reported that more powerful lights were needed in Sydney street, from the north side of King Square to Union and he was given authority to ask the Civic Power Commission to install these.

It was reported by the Civic Commission that the amount of current taken by the city from the New Brunswick Electric Power Commission was as follows: July, 1,500 k. w. h.; August, 16,000 k. w. h.; September, 43,300 k. w. h.

Commissioner Frink reported that all the land from one hundred feet to the east of Broadview avenue was decided to the City of St. John in 1880 and moved this report be placed on the agenda until the meeting of the Lewis Boulevard is taken up.

A request from the United Automobile Tire Co., for permission to place a light on a pole belonging to the N. B. Power Co., at the head of Prince Edward street, was referred to the Commissioner of Public Works, city engineer and road engineer for a report.

The Breakwater. A communication from Alex Gray, resident engineer of the Federal Public Works Department, asking that an agreement for the removal of rock from Partridge Island be prepared by the city solicitor outlining the conditions under which the contractor for the Negro Point Breakwater extension be allowed to remove same, was referred to the Commissioner of Harbors and city solicitor with power to act.

Commissioner Frink said he was very glad to hear this communication and he had previously admitted the city's ownership of the island.

Commissioner Wigmore thought the removal of this rock would benefit the wharf and this request looked as though action on the extension of the breakwater was to be begun soon.

Wiggins' Wharf. Commissioner Bullock presented a report on the cost of repairing the Wiggins Wharf and said this would cost \$11,200. Probably the only one requiring the wharf was the Public Works Department.

Commissioner Frink said he would not ask for such expenditure for the purpose of housing one horse and a wagon. It would be better to rent a shed or bull.

Commissioner Wigmore said the city owned a lot at the corner of King street and Market Place and a building might be erected there to house the water and sewerage department and public works on the West Side. Under these conditions Commissioner Bullock moved that the entrance to the Wiggins Wharf be closed to team traffic.

Carried. Commissioner Bullock reported that it would cost \$6,000 to reconstruct the public wharf at Indiantown and he submitted a recommendation from the engineer that the work be undertaken and a start be made at once. The cost of the wharf last year was \$169 and it cost \$300 per year to collect this amount. He moved the work be undertaken and paid for by bond issue.

Commissioner Thornton said he would like more information before voting on the matter and moved the matter lie on the table for the present. Carried.

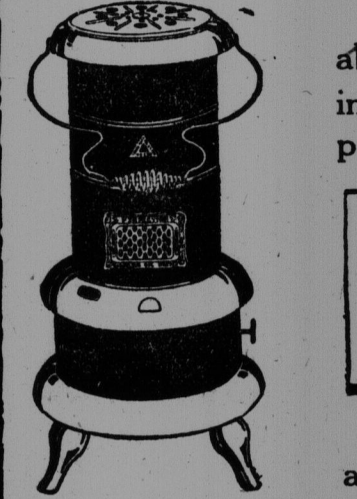

The present car had been in service for seven years and a new one was needed now. The price would be about \$1,800. The authority asked for was granted.

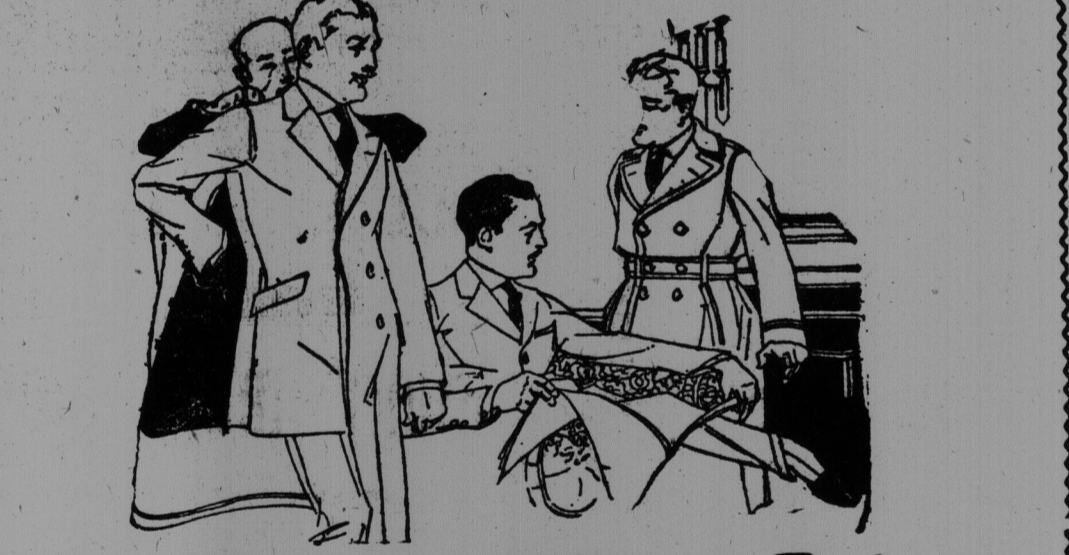
