

OKU, TOGO OCH OTAMA.

Generalen baron Oku är 57 år gammal och en samurai af Otta-klassen. Tidigare — det vill säga före det nu pågående kriget — har han varit befälhavare för japanska "ostarmen". Dessförinnan anförde han en expedition till Formosa för att kväva ett uppror på den från Kina förvärfvade ön. Nu i ryska kriget har general Oku utan gennäggelse varit den mest segerrika öfverhuvudet de japanska generalerna. Sedan Kuroki öppnat segrarnas rad genom Yalu-slaget den 1 Maj, har Oku följt japanernas triumftåg i Mandchuriet och lagt seger till seger. Borjan gjordes den 25-26 maj, då japanerna genom den blodiga drabbningen vid Kintajao och Nanshan utspårade Port Arthur från förbindelsen norr ifrån. Då sedermera general Stackerberg skickades med sin här söderut för att undsätta Port Arthur, bled han af Oku i grundslaget och hans här upplöstes i de mordande striderna vid Vailangu och Telisse omkring den 14 juni. Ryssarne uppgav själva sina förluster vid Vailangu till 2,000 döda förutom oerömda massor af sårade. Bland de strider som general Oku segrariskt utkämpat ma särskildt nämnas 15-timmarslaget vid Taspsjao den 23 juli, samt striderna vid Simuta cheng och Hait cheng den 30 juni-1 augusti, hvarvid även generalerna Nodzu och Kuroki med sina här deltog i trupperörelserna. Kriget har ännu icke haft ett uppväsende enda slagen japansk general, och baron Oku är nog helt den, som lemnat de flesta och kanske även de mest betydande segrarne till lands.

Följande beskrifning af amiral Togo — hemtas ur Colliers Weekly: "Efter det vi stutit i gunrummet en stund, inträdde kapten Takabe och tillkännagaf: 'Mina herrar, amiral Togo.' Alla reste sig och riktade blicken på den lille officeren, liten även efter japansk mätt, där han stod i dorroppningen. Där stod han, den japanska flottans överbefälhavare, en iug sextiåring, med beslutsamhet och järnviljan präglad öfver hela sitt väsen. Hans kolsvarta hår stod som borst rätt upp, ögonen föradade intet, men de kraftiga kindbenen talade om styrka, uthållighet, energi. Luga är ett framträdande drag hos amiral Togo. Han sag på de församlade utan minsta tecken till intresse eller sinnesörelse. Det lag intet ovanligt i blicken, hvilken snarare talade om djup tankspriddhet för stunden. Samma blick som amiral Nelson säges ha haft under en af sina ensliga nattvakter utanför Brest eller Toulon för hundra år sedan. Togo är iärdig, ordkarg och en man med järnvilja. Jag har aldrig träffat någon, som så öfverväldigande givit mig förmånen af verklig storhet, en människorna i allmänhet vida öfverlägsen personlighet. Jag skall aldrig förgäta talfallen af honom, där han stod i Mikasas guurum, omgiven af sin stab och stormarkens representanter.

Kortare till gestalten än någon annan af de närvarande, utgjorde han dock, likt den fruktade korsikanen, huvudfiguren, samlingspunkten för alla blickar. De skilda nationernas beskickningar, af hvilka hyste verklig fiendtlighet till Japans sak, erlora genast i denne sjuhåttade närvaro hans färdande inlytande, och, förgätna de alla mellanvaranden, tillade de förmigen om att få trycka hans hand. Men Togo själf förblev obörd. Hans blick stirrade allti-jämt, oförändrad, frånvarande såsom han måste ha blickat för tio år sedan dagarna innan han sköt Kowshuig i sank med dess 2,000 kinesiska sjösoldater ombord, en tilldragelse, som väckte världens uppmärksamhet på en uppgående stjärna i det fjärran östern. Vi drucko amiralens skål i champagne, och han besvarade denna artighet med ett nätt och jämt lappja på det pärlande vinet. Detta var ej ett utslag af ohöflighet eller höfdragenhet; det visade blott, att amiralen i verkligheten befann sig annorstädes med hela sin själ, utanför Port Arthurs fästning, fyratio mil borta, där han när som helst kunde vänta att få se den ryska flottan sticka till sjös.

Längre ifrån att vara den barske grobian, som man gärna vill föreställa sig en sådan krutgubbe som Oyama, är denne Japans öfverlägsne fältmarskalk den mest hjärtlige, frytliche och välvillige gamle kaptanen, man kan träffa på. Sväl bedyrar han, att han aldrig hållt båg för krigarnes yrke, och att det

på hvar och en.

Vid begravningsfaktages att
dessa så vidt möjligt är ske i öf-
verensstämmelse med den allmæns
egen religion.
De personliga tillhörigheterna ef-
ter en japan skola packas tillsam-
mans och jämte den allmæns strup-
hulvad och här föras med uppgitt
om den dödes namn och tjänste-
ställning samt sändas till divi-
sionshuvudkvarteret. De stupade
fiendernas effekter skola behandlas
på ett lika omsorgsfullt sätt och
krigsfångar i Tokio.

Döda hästar skola halsades
af en särskild kommission, som
brännas eller begravas. Om det
är nödvändigt att begrava dem,
skola särskilda sanitära åtgärder
vidtagas.
