2. Lady Listowel, a journalist of note, has travelled widely in Europe and abroad, and lectured in the U.S.A. since the outbreak of the war under the auspices of the Ministry of Information.
3. All available Other Ranks, T.O.S. or attached, Headquarters, Cdn. Reinf. Units, will attend this lecture, which will be held in the Men's Mess Hall.
4. Other Ranks will be forced up on Sections Parade Ground by 1910 hours and marched to the Mess Hall in time to be seated by 1920 hours. This to be considered as a parade and after duty passes are hereby cancelled until after the lecture.
5. The s/Corp Sergeant Major will detail three N.C.S.'s to act as ushers.
6. Employment platoon will be responsible for the erection of a small platform and necessary seating arrangements.

## 78 SIGNING OF WORK TICKETS AND DUTY CARDS AND CARDS FOR RECREATIONAL TRANSPORTATION.

1. In the past, drivers of this H.Q. have been in the habit of proceeding to pick up officers with the work ticket made out, but not signed, the practice being to obtain the signature of the officer who ordered the car when the car reaches him, whether it be at his mess, Messhall Lodge, a railway station, or anywhere else in the 20 mile limit. In some cases the work ticket has not even been filled in as to destination.
2. This procedure is entirely wrong, as:-
  - (a) The signature in most cases is not that of an officer authorized to sign for vehicle journeys.
  - (b) The driver is without any authority at all while enroute to the officer, and should be checked by military police, or become involved in an accident, severe consequences may follow.
3. In the future, therefore, no vehicles of Headquarters, Canadian Reinforcement Units, will proceed on a journey without the work ticket authorizing the journey being signed by:-
  - (a) The Corp Commandant or Transport Officer during office hours or,
  - (b) The Duty Officer at all other times.
