

Bill, to consolidate the indebtedness of the Town of *Stratford*, in the County of *Perth*. Bill, for improvement of the *Napanee* River.

They have also considered the Bill, from the Legislative Council, intituled, "An Act "to place the Wesleyan Methodist Church and property, situated on the South side of " *Queen* street, in the City of *Toronto*, under the directions of the 'Model Deed' of the " Wesleyan Methodist Church, in connection with the English Conference, for the better "management thereof, and to vest the same in certain Trustees under said Deed," and they have agreed to report the same, without amendment.

*Ordered*, That Mr. *Poupore* have leave to bring in a Bill for establishing the boundary lines between certain Ranges in the Township of *Onslow*.

He accordingly presented the said Bill to the House, and the same was received and read for the first time; and ordered to be read a second time, to-morrow.

*Resolved*, That an humble Address be presented to His Excellency the Governor General, praying His Excellency to cause to be laid before this House, a detailed Statement of the Expenses to the Country of the Civil Service Board of Examiners since 1857, the number of meetings held by such Board, the number of candidates who have presented themselves for examination, the number of those to whom certificates of qualification have been granted, the number and names of such parties as have obtained public employment and the emoluments attaching to their several positions; also the names of parties who have been employed in the Public Service either temporarily or permanently who never received certificates of qualification from the Board of Examiners for the Civil Service, the length of time such parties have been employed, and the emoluments attaching to their several positions.

*Ordered*, That the said Address be presented to His Excellency the Governor General, by such Members of this House as are of the Honorable the Executive Council of this Province.

On motion of Mr. *Parker*, seconded by Mr. *Dickson*,

*Resolved*, That an humble Address be presented to His Excellency the Governor General, praying His Excellency to cause to be laid before this House, a Return shewing approximately the unpaid amount on account of all Sales of Crown lands in each of the Counties of *Wellington*, *Grey* and *Bruce*, and the probable value of the unsold Crown Lands in the said Counties.

*Ordered*, That the said Address be presented to His Excellency the Governor General, by such Members of this House as are of the Honorable the Executive Council of this Province.

On motion of Mr. *Pope*, seconded by Mr. *Webb*,

*Resolved*, That an humble Address be presented to His Excellency the Governor General, praying His Excellency to cause to be laid before this House, a copy of all Tenders, contracts and specifications, and all papers and documents respecting the contracting or building the *Sherbrooke* Gaol, also Report of the Inspector of the works (if there is any) as to the present state and quality of the work.

*Ordered*, That the said Address be presented to His Excellency the Governor General, by such Members of this House as are of the Honorable the Executive Council of this Province.

On motion of the Honorable Mr. *Cameron* (*Peel*), seconded by the Honorable Mr. *Dorion* (*Hochelaga*),

*Resolved*, That an humble Address be presented to His Excellency the Governor General, congratulating His Excellency upon His elevation to the Peerage of the United Kingdom of *Great Britain* and *Ireland*, and expressing the satisfaction and gratitude of this House, that Her Most Gracious Majesty has thus acknowledged the Services of His Excellency, in His faithful Administration of the Affairs of this Province.
