

Debate in the House of Commons

Which Preceded the Dismissal of Mr. Killackey.

MR. PELLETIER'S CASE ALSO RE-FERRED TO-MR. CAMPBELL SAYS TR. TICQUEEN WAS MARTYRED.

A few days ago! The Planet promised to publish the Hansard report of the discussion over the dismissal of officials to prove that the Banner misrepresented Mr. Killackey's case. The debate was a very long one and was participated in by msmy members. Mr. McGregor, of Hasex, was one of them. Among other things he said:
