Mr. Prittie: The hon. member for Timiskaming has brought up some very important points, I believe. He has expressed the feelings of many private members in this house. There are many ways of expediting business, and if the Prime Minister wants that hatful of legislation passed, I think means will have to be found other than we have been able to find so far. I do not believe the committees system is being used as it should be. This complaint has been expressed by many of the new government backbenchers.

So far in this session we have not had departmental estimates referred to any of the committees. It seems to me that before much longer estimates such as those of the Department of Veterans Affairs should be referred to the veterans affairs committee, which could be working on them. The estimates of the Department of Fisheries could go to the standing committee on marine and fisheries. The committee which looked over the reports of Canadian National Railways and Trans-Canada Air Lines has not been called into session as yet, and this is something we must do before the session ends. All of these committees should be used, and used immediately. Not all the departmental estimates can be referred to the committees, but many of them can be. So far we have just had three committees working, namely the external affairs committee dealing with the Columbia river treaty, the committee on privileges and elections and the committee looking after the rules. I think if we subdivided some of the work and got it out of the house into committee, we would make more progress.

I like the idea presented by the hon. member for Timiskaming concerning some regularity of sessions. Being a member of parliament is a full-time occupation now. In the United Kingdom they say that at certain times of the year the house will sit and other times it will not. I suspect one of the real problems in this whole situation is that there are some people on the government side and some people in the official opposition who do not want the house to function. It seems to me that some members of the official opposition want an election so that their leader will get one more chance to be prime minister. I am sure that
