LETTER CARRIER SERVICE, WEYBURN, SASK. Question No. 2,246—Mr. Watson (Assiniboia):

1. When was the last survey made in the city of Weyburn, Saskatchewan, by the Post Office Department, with a view to implementing letter carrier service?

2. What was the result of that survey?

3. Is it expected that letter carrier service will commence in 1964 and, if not, what is the earliest date this service could be expected?

#### Hon. J. R. Nicholson (Postmaster General): 1. The last survey was in September 1964.

- 2. It indicated that there were 2,528 available calls for letter carrier delivery and as a result this service was approved.
- 3. Letter carrier service will commence early in 1965 as soon as 80 per cent of the homes have been equipped with the necessary mail receiving facilities.

# REQUEST FOR OLD AGE PENSION INCREASE Question No. 2,248—Mr. Howe (Hamilton South):

Has the government received representations from the senior women's committee for pension increase, requesting an increase in the old age pension to \$100, tied to the cost of living, and a reduction of pension age to 65 years and, if so, what has been their reply?

Hon. Judy V. LaMarsh (Minister of National Health and Welfare): Yes, the Minister of National Health and Welfare had a long discussion with representatives of this committee.

As any change would involve a matter of government policy, an announcement would be made by the government at the appropriate time.

### EXTENSION OF COMBINES ACT EXEMPTION FOR B.C. FISHERMEN

#### Question No. 2,258-Mr. Howard:

With reference to the provisions of the Combines Investigation Act that nothing in the Combines Investigation Act or in section 411 of the Criminal Code shall be construed to apply to any contract, agreement or arrangement between fishermen or associations of fishermen in British Columbia, and persons or associations of persons engaged in the buying or processing of fish in British Columbia, relating to the prices, remuneration or other conditions under which fish will be caught and supplied to such persons by fishermen, which will expire on December 31, 1964, are any steps being taken to extend the said provisions beyond that date and what are those steps?

Mr. D. S. Macdonald (Parliamentary Secretary to Minister of Justice): The matter of extension of this legislation as contained in chapter 4 of the 1962-63 statutes of Canada is receiving careful study and any decision to amend the legislation will be made known in due course in the proper way.

#### Question No. 2,262-Mr. Coates:

- 1. How many applications for student loans have been received to date?
- 2. Of the total number of applications, how many have been approved to date, how many rejected, and how many are still under consideration?
