Hon. James Richardson (Minister of National Defence): 1. The cost of training the following trades and professions for 1974 is as follows excluding pay to the students: (a) and (h). Transport Pilot and long-range pilot, \$270,648; (b) Combat pilot, \$301,668; (c) Radio Navigator, \$89,054; (d) Dentist, \$10,980*; (e) Medical Officer, \$6,102*; (f) Lawyers are usually recruited following qualification and admission to the bar. The only training costs involved are those common to all officer classifications such as recruiting and officer cadet school costs, these total \$5,446; (g) Tank Driver, \$12,993; (i) Marine Engineer, \$16,400*; (j) Construction Engineer, \$18,881*; (k) Computer Programmer, 25,628*.

Box 1238, Sackville, N.B. \$48,000; (b) Eleck Imredy, 2132 Yew Street, Vancouver, B.C. \$56,000. These payments were made through the Working Capital Advance and the costs recovered from the Secretary of State Department. (c) The Department of the Secretary of State paid \$2,800 to Elford Cos, Willowdale, Ontario, to produce a maquette.
