## PRICE OF CRUDE OIL

Mr. Russell MacLellan (Cape Breton-The Sydneys): Mr. Speaker, my question is for the Minister of Energy, Mines and Resources. The Minister's market sensitive system is a disaster. Consumers have received practically no benefit from falling world oil prices. The industry is in such a state of uncertainty that it is going to ask the Government to scrap deregulation and to step in and save it from collapse. When will the Government step in?

Hon. Pat Carney (Minister of Energy, Mines and Resources): Mr. Speaker, I am really surprised that the Hon. Member would ask that question. The last time the Government stepped in, it created the National Energy Program which devastated the western economy.

#### MINISTER'S POSITION

Mr. Russell MacLellan (Cape Breton-The Sydneys): Mr. Speaker, to use the Minister's own words, she said that such low prices would be "catastrophic" for the industry. What is she planning to do about the catastrophe facing the industry?

Hon. Pat Carney (Minister of Energy, Mines and Resources): Mr. Speaker, I think it is quite important that the Hon. Member not add to the hysteria which his Party is generating at this time. If he is referring to the volatility in oil prices, may I point out, as Premier Getty and others have pointed out, that this is a price war. Prices are very volatile, and we do not know where they will stabilize.

REDUCTION IN OIL PRICES—ATTITUDE OF MULTINATIONAL OIL COMPANIES—MINISTER'S POSITION

Mr. Raymond Garneau (Laval-des-Rapides): Mr. Speaker, my question as well is directed to the Minister of Energy, Mines and Resources.

Oil prices have gone down 60 per cent in the past four months, from \$30 to \$12 U.S. a barrel. Consumers in the United States have long since been benefiting from this reduction, yet in Canada the decrease has been a mere 2 cents a litre.
