Hon. John Wise (Minister of Agriculture): No. However, reductions will be applied to research conducted for the Department by industry and universities, which has been funded by research contracts and extra mural grants. The savings will be implemented by not accepting any new proposals rather than by cutting currently approved activities.

#### AID TO NICARAGUA AND CHILE

## Question No. 191-Mr. Stackhouse:

Is Canada giving aid to (a) Nicaragua (b) Chile and, if so, in each case (i) since what date (ii) in what amounts (iii) for what purposes?

Hon. Monique Vézina (Minister for External Relations): In so far as the Canadian International Development Agency is concerned, the answer is as follows:

(a) Canadian aid to Nicaragua: Bilateral aid. In 1975, following the earthquake which destroyed much of Managua, the capital of Nicaragua, Canada loaned the country \$1.9 million to purchase heavy equipment to remove the rubble from the centre of the city. The loan has been used and \$1,887,600 has been paid out.

In 1982, CIDA financed a technical assistance project worth \$655,000, in the form of a grant-in-aid, for the development of a food strategy. The project has been completed.

In January, 1984, Canada extended a line of credit of \$13.4 million for the provision of fertilizer, farm equipment and Holstein heifers (\$13 million loan and \$400,000 grant-in-aid). To date, about 50 per cent of this line of credit has been used.

In September, 1984, Canada extended a line of credit of \$7.5 million (\$7 million loan and \$500,000 grant-in-aid) for the provision of equipment for the drinking water sector. This credit has not been used to date.

Other forms of aid: Canada also provided aid through CIDA's other co-operation mechanisms. During the last four years (1980-81 to 1983-84) Canada has contributed over \$24 million to support projects in Nicaragua through the mission administered funds, non-governmental organizations, institutional co-operation and development services, and industrial co-operation programs. In addition, emergency food aid in 1981-82 and 1983-84 was provided for humanitarian reasons.

(b) Canadian aid to Chile: Chile has not received any bilateral aid from Canada since 1973. However, Canada provided aid through several of CIDA's other co-operation mechanisms. During the last four fiscal years (1980-81 to 1983-84), Canada contributed \$3.7 million to support projects in Chile through the mission administered funds, non-governmental organizations, institutional co-operation and development services, and industrial co-operation programs.
