CANADA-UNITED STATES TRADE AGREEMENT—EFFECT ON ENERGY INDUSTRY

Mr. Ian Waddell (Vancouver—Kingsway): Mr. Speaker, I want to speak about the free trade deal in energy. About a year and a half ago, I stood in this House and predicted that we would have a continental energy policy in a short time. That is exactly what the Mulroney trade deal has done. ELIGIBILITY OF NORTHWESTERN SASKATCHEWAN AREAS FOR NORTHERN TAX STATUS

Mr. John Gormley (The Battlefords—Meadow Lake): Mr. Speaker, I would like to inform Members of the House of a decision made this week by the Minister of Finance (Mr. Wilson) which more clearly defines the areas eligible for northern and isolated tax status. After months of meetings, negotiations and presenting petitions and letters on behalf of my constituents on this issue, I am delighted that certain areas of northwestern Saskatchewan will now be eligible for northern tax status. These areas include Meadow Lake, the rural municipality of Meadow Lake, Makwa, Loon Lake, Dorintosh and Rapid View.

This tax status means that, effective the 1987 tax year, people living in those areas will be eligible to claim a special tax deduction of up to 20 per cent of net income to a maximum of \$5,400. It is encouraging to know that the Minister of Finance and his officials have recognized that additional costs do come with living and working in the North. I speak on behalf of all my constituents when I thank the Minister and all of the citizens of the communities involved for their diligence and persistence in this matter.
