Imagine what it says to the people in the Armed Forces and to a place like CFB Cornwallis that does recruit training. Imagine what it says to the laid-off people and the businesses in the CFB Cornwallis area.

It makes absolutely no sense to send 826 Canadians to California to be trained in peacekeeping when we have the facilities in Canada.
