SENATE

Hon. Mr. WATSON: It is not the money part of it I am considering. We can raise the money; but I think that a celebration of this kind should be held when the people are in good spirits. So far as I am personally concerned, I will, as a member of that committee, advise against the holding of any celebration at the present time. I notice that it was suggested in the Speech from the Throne that there should be a celebration this year. Evidently the Government came to that conclusion; but I suppose that when a committee is appointed it is to have a free hand in determining whether it should recommend a celebration or not. As I say, I feel personally that we should have no celebration at the present time, but that it should be deferred until the war is ended and victory is proclaimed. We may be able to have a celebration of the opening of our new Parliament Buildings at the same time. Regarding the question whether the celebration should be held in Ottawa or in Hull, I do not know whether my honourable friend would prefer to go to Hull or to stay in Ottawa.

Hon. Mr. CLORAN: That is the reason I did not want Ottawa selected: it is too near to Hull.

Hon. Mr. McLENNAN: The difficulty could be overcome if we look on the event as a commemoration rather than a celebration—if the fifty years of Confederation could be marked soberly and quietly at the time they are fulfilled—the 1st of July, I think, is the official date—without any of the merry-making and extravagant moneyspending phases which all of us are inclined to associate with celebrations.

The motion was agreed to.
