"Justice."

(n.) The expression "justice" means a justice of the peace acting for the district, county, riding, division, city or place where the matter requiring the cognizance of a justice arises, and who is not interested in the matter; and when any matter is authorized or required to be done by two justices, the expression "two justices" shall be understood to mean two justices assembled and acting together:

"Lands,"

justices assembled and acting together;
(o.) The expression "lands" means the lands, the acquiring, taking or using of which is incident to the exercise of the powers given by this or the special Act, and includes real 10 property, messuages, lands, tenements and hereditaments of any tenure;

"Lease."

(p.) The expression "lease" includes an agreement for a lease;

"Minister."

(q.) The expression "Minister" means the Minister of 15 Railways and Canals;

"Near."

(r.) A railway shall be deemed to come "near" to another when some part of the one is within one mile of some part of the other;

"Owner."

(s.) The expression "owner", when under the provisions of 20 this Act or the special Act, any notice is required to be given to the owner of any lands, or when any Act is authorized or required to be done with the consent of the owner, means any person who, under the provisions of this Act, or the special Act or any Act, incorporated therewith, would be enabled to 25 sell and convey lands to the company;

' Plan."

(t.) The expression "plan" means a ground plan of the

lands and property taken or intended to be taken;

"Railway."

(u.) The expression "railway" means any railway which the company has authority to construct or operate, and includes 30 all branches, sidings, stations, depots, wharfs, rolling stock, equipment, stores, property real or personal and works connected therewith, and also any railway bridge, tunnel, or other structure which the company is authorized to construct;

"Rolling stock."

(v.) The expression "rolling stock" means and includes 35 any locomotive, engine, motor car, tender, snow plow, flanger, and every description of car or of railway equipment designed for movement, on its wheels, over or upon the rails or tracks of the Company;

"Secretary."

(w.) The expression "Secretary" means the Secretary of 40 the Board:

"Sheriff."

(x.) The expression "sheriff" means the sheriff of the district, county, riding, division, city or place within which are situated any lands in relation to which any matter is required to be done by a sheriff, and includes an under sheriff or other 45 lawful deputy of the sheriff:

"Special Act." (y.) The expression "Special Act" means any Act under which the Company has authority to construct or operate a railway, or which is enacted with special reference to such railway, and includes all such Acts;

"Toll."

(z.) The expression "toll" or "rate" means and includes any toll, rate or charge made for the carriage of any traffic, or for the collection, loading, unloading or delivery of goods, or for warehousing or wharfage, or other services incidental to the business of a carrier;

(aa.) The expression "to charge," when used with respect to tolls, means and includes to quote, charge, demand, levy, take or receive;
