Charlottetown and Murray Harbour? If so,

when is the service to begin?

2. Is the Railway Department, or the government aware that the postal service along the route of the railway is inadequate and very unsatisfactory to the whole section of the province?

Hon. G. P. GRAHAM (Minister of Railways and Canals):

1. The business does not warrant any increase in the train service at present.

2. No doubt additional service would be appreciated, but the financial conditions would not appear to warrant it.
