HOW THOSE AMERICANS LOVE US!

The correspondent who furnished The St. James' Gazette with a letter on the situation in Canada seems to have stirred up a hornet's nest. The United States papers are after him with a sharp stick. What they especially take umbrage at is his assertion that the United States is deliberately unfriendly and hostile towards Canada. On this subject the correspondent wrote:

Dislike, when it is not mere fancy, is jealousy or jealousy or to a sense of injury in act or in intention. Now, jealousy is out of the question in this case. Canada has no pretensions to rival her neighbor in wealth and population, and no desire to rival her in any other respect. Her only content is to be an integral part of an empire very much larger, wealthier, more populous, more powerful and more famous than the United States. Her hostility is due entirely to a sense of injury—injury inflicted and intended.

As an illustration to support this general allegation, the correspondent refers to the "Behring Sea" case, deliberately kept open by the Washington Government, and he adds, "then there is the lumber duty, which is intended to injure the Canadian sawmill industry."

The New York Journal answers the correspondent's charge in regard to the Behring Sea episode by stating that "the seals which breed upon the Pribyloff Islands are ours; what we object to is the slaughter of the females with young while they are away from their feeding at sea. England has refused to join with us in measures which will put an end to pelagic sealing."

Such being the case, The Journal wonders why England should marvel at American suspicion of Great Britain's good-will.
