

PROGRAMME FOR CORONATION DAY

THE PUBLIC WILL BE ASKED TO SUBSCRIBE

Coronation Day Reserved for Public Ceremonies—Baseball and Sports on Friday and Saturday.

A public meeting was held in the city hall last night to consider the recommendations of the special committee appointed to draft a programme of the celebrations in connection with Coronation Day.

Mayor Hayward presided and among those present were: D. Helmecke, M.P.P., Rev. Elliott S. Rowe, Ald. Worthington, W. J. Hanna, A. J. Dallain, Chief Watson, Geo. Jeeves, Ald. Graham, Dr. Milne, E. E. Lenson, J. W. Maynard, W. H. Price, J. Dalby, J. G. Darling, J. Fullerton, Sergt. Redgrave and Capt. Ridgway Wilson.

The following is the programme recommended by the committee for Coronation Day (June 29th) and following two days, and adopted after some discussion last night:

Thursday. Morning—Review of army and navy at Esplanade Point. Afternoon—Coronation ceremonies at government buildings. Evening—Band concert in front of government buildings.

Friday. Morning—Baseball, Leland-Stanford University vs. Victoria, at Oak Bay. Afternoon—Parade through city. Societies' Reunion at Caledonia park, sports and games. Evening—Band concert at Beacon Hill park and at the corner of Yates and Douglas streets.

Saturday. Afternoon—Baseball, Stanford University vs. Victoria, at Oak Bay. Evening—Band concert, corner of Government and Johnson streets.

The expenditures recommended by the committee totalled \$1,000 and was made up as follows: Bands, four concerts at \$30, \$250; printing, advertising, \$25; decorations, \$350; sundries, \$200.

Mr. Fullerton pointed out that the vote for the bands did not include music for the Societies' Reunion. He thought that, as the reunion was to be held entirely for charitable purposes the committee might help to the extent of subscribing towards the cost of the band on Friday afternoon.

Mr. Helmecke moved that the question of supplying music for the Societies' Reunion on Friday afternoon be referred to the committee for favorable consideration.

This was agreed to. A discussion arose in regard to the raising of the \$1,000 recommended for expenditure. Mr. Helmecke moved that the corporation ought to give something towards the celebration.

He had no doubt but that the citizens would also subscribe. A finance committee ought to be appointed.

Geo. Jeeves suggested that the council should put the whole case. Chief Watson remarked that when they had collected for the Victoria Day celebrations it had been understood that the citizens would not be asked to subscribe towards the coronation festivities.

Eventually a finance committee was appointed, consisting of Messrs. Helmecke, Jeeves, Milne, Wilson, Lenson, Dallain, Watson, Maynard, Hanna, Dalby, Graham, Price and Worthington, and a motion that the corporation should be requested to put up \$1,000 more or less was agreed to.

Mr. Lenson pointed out that there was no necessity to tie the expenditure down to \$1,000. If more could be raised the balance could doubtless be well laid out.

The mayor and the members of parliament for the city were appointed a special committee to arrange the official ceremonies on Coronation Day. At the mayor's suggestion it was agreed that the ceremony should include the adoption at the public gathering at the government buildings of an address to the King and Queen.

Messrs. Worthington, Redgrave, Price, Hanna and Dallain were selected for the band committee.

Messrs. Jeeves, Dalby, Watson, Macdonald and Capt. Ridgway Wilson were appointed to the decorations committee; and Messrs. Sexton, Lenson, Wilby, Lugin, Walker and Darling were selected for the printing, advertising and transportation committees.

On the motion of Capt. Wilson it was agreed that the printing committee should be authorized to commence work at once and be voted \$150 for that purpose.

Acting Secretary Leeming was appointed secretary and Ald. Vincent treasurer; and the committee of thirty, appointed at the last meeting to draw up the programme, was appointed a general committee to transact all further business in the place of public meetings.

A letter from Messrs. Hill, Bros., offering to supply a fire display to include set pieces representing the King and Queen, etc., was laid over until financial arrangements could be completed. The meeting then adjourned.

NEW FRENCH CABINET.

Paris, June 6.—The following list of ministers has been semi-officially announced: M. Combe, premier, minister of the interior and minister of public works; Senator Valle, minister of justice; M. Delcasse, minister of foreign affairs; Gen. Andrein, minister of war; Deputy Marjules, who was minister of commerce in the Brisson cabinet, minister of marine; Senator Chauvin, public construction; Deputy Pelletan, minister of public works; Deputy Doumergue, minister of colonies; Deputy Trouillot, who was minister of the colonies in the Brisson cabinet, minister of commerce; Deputy Mougeot, minister of agriculture; Deputy Rouvier, who probably be minister of finance.

MORE POWER WANTED.

Mayor Fletcher, of Nelson, in the City—Kootenay Mining Matters.

Frank Fletcher, Mayor of Nelson, with the engineer of that city, is here interviewing the government with the view to securing some of the waterpower of the Kootenay river for increasing the supply of civic light and power.

A recent change in the Municipal Clauses Act allows cities to secure waterpower for their own benefit, and it has been thought desirable to incorporate the Nelson to acquire some of the power below the town.

Mayor Fletcher states that the experimental refinery at Trail is already turning out fifteen tons of kerosene from the bullion smelted there, which would offer an abundant supply for the pulp manufacturing, which it is hoped will be established in Nelson.

The mining industry shows signs of revival, a great deal of work being done in the Ymir section, and the output at Ainsworth has increased considerably. The Athabasca and Venus mines near Nelson are now under management, and work is expected to start on them shortly.

WHY THE LOCAL ACT HAS BEEN DISALLOWED

Gazette Contains Privy Council Minute Regarding Act to Incorporate Lake Bennett Railway Co.

The current issue of the Provincial Gazette published last evening contains the minutes of the privy council containing its reasons for disallowing the act to incorporate the Lake Bennett Railway Co., passed by the provincial legislature, as follows:

The minister further observes that the territory between the ocean and that region which is proposed to be traversed by the line railway thus started is now in dispute between the United States and the Dominion of Canada, and it is considered inexpedient, pending the settlement of that dispute, to permit the construction of railways which may complicate and increase the difficulty already existing. The authority of a provincial legislature over railways is limited to such as are local in their character, and which do not connect the province with any other or others of the provinces, or extend beyond the limits of the province. The minister is of opinion that it is, therefore, very doubtful whether it is competent to the legislature of British Columbia to authorize the construction of this railway from the Dyea river to the Northern boundary of the province, and the attempt to keep the traffic of such a railway under the control of the local government, notwithstanding any legislation of parliament upon the subject, is also objectionable.

The minister considers that these two provisions, construed together, may furnish reasons for disallowance of this act, but in addition to these reasons, he does not consider it in the public interest or consistent with the policy of the government of Canada, that the act should remain in operation.

Henry Daniel, of Rossland, to be a member of the boards of licensing commissioners and of commissioners of police for the said city, vice Mr. F. J. Walker, resigned.

William Patrick Dempster, of Skidegate, to be a deputy mining recorder for that portion of the Skeena mining division known as Queen Charlotte islands, with subordinate office at Skidegate.

James A. Fraser, of Afton, to be stipendiary magistrate for the county of Vancouver; government agent, gold commissioner and assistant commissioner of lands and works for the Atlin lake, Bennett lake and Chilkat mining divisions; assessor and collector under the Revenue Tax Act for the Atlin assessment district, and collector of rates for that portion of the Cassiar electoral district contained within the boundaries of the Atlin lake, Bennett lake and Chilkat mining divisions, vice J. D. Graham, resigned; such appointments, resignation to take effect on July 1st, 1902.

The Sidney & Nanaimo Transportation Company has been incorporated with a capital of \$100,000, to take over the steamers Strathcona and Iroquois, which they propose to operate from Sidney along the east coast of Vancouver Island and to the islands of the Gulf.

The Quondora Mining Company has been registered as an extra-provincial company. The head office of the company is Brocktonridge, Cal., and the capital is \$800,000. The head office of the company in the province is Rossland, and Charles Hamilton, barrister of that city, is the company's attorney.

The new regulations for the disposal of Dominion coal lands in Manitoba, the Northwest Territories and British Columbia are published.

The Beaver Creek, Matsqui, Notch Hill, Pilot Bay and Sumbury school districts have been created, and the boundaries of the Gill and Delta school districts are redefined.

W. J. Taylor, of Victoria, has been appointed attorney for the Albert Copper Co. and Nabimint Mining Co., vice G. H. Hayes.

(Francis Hoteramp, hotel keeper, of Quesnelle, has assigned.

London, June 6.—The Hon. Michael Henry Herbert, recently appointed British ambassador to the United States, in succession to Lord Pauncefote, will be made a Knight Commander of the Bath before starting for Washington.

TO PRESERVE THE CALEDONIA PARK

IN DANGER OF BEING DIVIDED INTO LOTS

Association Being Promoted to Purchase Grounds From Mortgage—Scheme Explained.

The Caledonia grounds, for many years the favorite recreation resort of Victorians, are in danger of being divided into lots and sold for residential and other purposes. They have been surrendered to a mortgagee by the St. Andrew's and Caledonia Society, and it is understood are offered for sale. It is easily recognized that this is an ideal residential locality, but it is equally ideal for a place of recreation, and the disintegration of the grounds would be greatly deplored.

To rescue this admirable sporting place from such a fate an association is about to be organized with a capital of \$10,000. R. B. McKicking is promoting the movement and has aroused considerable interest. The grounds are offered for sale for \$85,000, and the idea is to purchase them, providing a working fund of \$1,500 immediately available for much-needed improvements. The capital stock of the association is to be divided into ten thousand shares at one dollar each. The object of the association is specifically stated in the prospectus as acquiring, preserving and improving the grounds, to make the grounds worthy of the capital city and to administer them in the interests of recreation and for the encouragement of legitimate, manly sport.

The grounds comprise five acres or more, and are bounded by Smeace, Carr, Niagara and St. Andrew's streets. Provisional managers will take charge pending the completion of organization and the grounds will be governed by articles of association framed by the stock holders after the stock has been sold. Those interested in the enterprise are concerned that an energetic management, improved grounds, comfortable accommodation for spectators and attractive competitive sports frequently held, a good return from the money invested will be realized, with a surplus for improvement when required.

It is pointed out that a reference to the receipts and expenditures in connection with the grounds in the past will show that under somewhat liberal management, when little encouragement was given to sports and less attention paid to the comfort of spectators, the surplus of revenue over expenditure netted an amount equal to six per cent on \$10,000.

The great objection against the Caledonia grounds has been the lack of space for certain games, baseball, for instance. The ball was frequently hit over the fence by some stalwart batter and lost. Those behind the proposed undertaking intend removing all room for objection on this point by enlarging the grounds considerably, if possible.

It is also intended in the course of time to remove the rocks in the northeast section of the grounds, allowing the construction of an amusement. The recreation area will be properly leveled and the grand stand will be improved and adjusted so as to give the spectators the best view of the various games. Mr. McKicking explained that the main object of the movement was to preserve the grounds in the interest of sport. He recognized that the grounds in question will do its utmost to make them attractive and a place for the best class of sport. He added that opposition to the Oak Bay park was not at all contemplated, and that the municipality so prolific of sports as Victoria there was ample room for two such places.

BODY OF GEO. KOENIG FOUND IN THE LAKE

Evidently Committed Suicide at Shawigan This Morning—Was Missing Since Five O'clock.

George Koenig, for many years proprietor of the Shawigan Lake hotel, was found drowned in the north end of the lake this morning. He had been missing since 5 o'clock, when he left the place ostensibly for the purpose of bringing in the cows. When several hours passed and he did not return, his wife and friends became anxious and a search was instituted. Nothing had been seen of him when the noon train passed, but not long afterwards his body was discovered near the outlet to the stream. His clothes were lying on the bank.

Those searching for him feared the worst when a note addressed to his wife was found in the safe. It was written in German, and in it the writer expressed sorrow for the manner in which he had treated her and implored her forgiveness.

The news of Mr. Koenig's death on the eve of the re-opening of his hotel came as a shock to his many acquaintances in this city. He was down a few days ago attending to general business and arranging for to-morrow's reopening. His act had evidently not been in contemplation very long, as the nature of the preparations made by him when he was such as to preclude this theory. It is not known here that he was worried by financial troubles, and the reason for his self-destruction is a mystery which may be made clear at the inquest.

George Koenig was a native of Germany, and has been in this country about fifteen years. Thirteen years ago he purchased the Shawigan Lake hotel, near Osoyoos. This was destroyed about six months ago, but was rebuilt on a more pretentious scale and was to have been reopened to-morrow. Mr. Koenig leaves a widow and two children.

FIVE OFFICERS DROWNED.

Giron, Spain, June 6.—A boat containing eight Spanish artillery soldiers, was run down by a steamer to-day and five officers were drowned.

Four per cent. of sailing vessels and two and a half per cent. of steamships are lost in a year.

A FAST SERVICE.

Four Day Schedule Between Vancouver and Montreal Goes Into Effect on the C. P. R.

The Imperial Limited service over the C. P. R. railway will be inaugurated with the Imperial limited train, No. 97, which will leave Montreal on Sunday, June 15th, and No. 98, which will leave Vancouver on Thursday, June 17th. These trains have been numbered Nos. 96 and 97 respectively, as this happened to be the number of hours' running time between the places, allowing for the stoppage at the various stations. The train will arrive in Vancouver on Tuesdays, Thursdays and Saturdays, and will leave Vancouver on Tuesdays, Thursdays and Saturdays.

The Imperial Limited train will have two first-class double drawing rooms, two first-class sleepers between Vancouver and Montreal, a first-class sleeper between Winnipeg and Montreal, and a first-class sleeper between Vancouver and Montreal. There will be no first or second class coach.

Trains leaving Seattle will make connection with the Imperial Limited at Mission Junction, eastbound, and close westbound connection will also be made at Mission Junction for Seattle.

Standard trains Nos. 1 and 2 will have to make three times a week as at present, a first-class sleeper between Seattle and St. Paul, and a first-class sleeper between Winnipeg and Toronto four times a week.

LEGAL NEWS.

On the application for a writ of habeas corpus on behalf of Joseph Genette yesterday afternoon the Chief Justice held that the warrant issued by C. D. Macanlay, a Dawson magistrate, upon which Genette was arrested, was valid, as he failed to state whether the prisoner was accused of having committed the offence alleged. He allowed the prisoner to go on condition of his submitting to re-arrest if a proper warrant is issued by the Chief Justice within the point raised as to whether a prisoner could be taken through American territory was not decided. F. Peters, K. C., made the application on behalf of the prisoner, and W. H. Langley, for the Crown.

The following applications were disposed of by the Chief Justice in Chambers this morning: Vernon vs. Cargill et al.—W. H. Langley, for one of the defendants, moved to set aside an order for substituted service. A. P. Laxton opposed the motion, which was dismissed with costs.

St. Mining Co. vs. Byron White Co.—An application for leave to set down an appeal for the coming sitting of the Full court was stood over until Monday next, a stay of proceedings being granted in the meantime. F. B. Gregory for plaintiffs, J. H. Lawson, Jr., for defendants.

P. Walls obtained an order for letters of administration with will annexed.

Mr. Justice Martin Chambers heard the further argument in the application for the further time in which to enter the appeal in Ward vs. Bank of N. A. et al., in which case the transcript of evidence and exhibits were lost for some time. His Lordship granted a peremptory order that the appeal be entered for the next court, on the terms of the applicants paying the costs of this application before entering the appeal.

NEW SPANISH MINISTER. Madrid, June 6.—Senor D'Ojeda, the former Spanish minister to Morocco, has been gazetted minister of Spain at Washington, in succession to the Duke of Salaparuta, former minister to Belgium. Senor B. J. De Colon, former Spanish minister at Pekin, succeeds Senor D'Ojeda at Tangiers.

BRITISH EMPIRE LEAGUE.

The General Meeting Discussed Restoration of Peace Last Night.

T. G. Fitcher presided at the general meeting of the British Empire League, which was held at the city hall last evening. On the suggestion of Senator Macdonald the president and secretary were instructed to draft a resolution congratulating Hon. Joseph Chamberlain on the restoration of peace. After an address by Seymour O'Dell on the characteristics of the Boers, a discussion ensued regarding the best way of celebrating the return of peace, it being generally felt that Sunday night's service was insufficient. Ex-Mayor Redfern observed that a day of thanksgiving would likely be proclaimed in England, which could be observed here. Mr. Grant in a concise and interesting speech dealt with the trade possibilities

MAN ARRESTED

Charged With Culpable Homicide—Squid to Collapse of Grand Stand.

London, June 6.—A sensation developed at the investigation into the Glasgow football accident of April 5th last. A man named Alexander McDougall was indicted on the charge of culpable homicide in the erection of a stand which collapsed on the occasion of the match between England and Scotland, and resulted in 21 persons being killed and 25 injured.
