Inquiries of the Ministry

Mr. Eldon M. Woolliams (Calgary North): A and discuss with the chartered banks whether money is still being advanced to big industry in order to assist it while small business is being cut off because of the tight money supply in Canada?

Mr. Benson: Mr. Speaker, I am not sure that the allegation made by the hon. member is correct. However, I should point out in fairness to the banking system that lines of credit are granted in advance for a period of time and it is very difficult for the banking system to contract these lines of credit unilaterally and immediately. Therefore it takes some time for the tightness in the money supply to work through the system and to apply exactly to those people to whom one wants it to apply.

SWAP DEPOSITS-EFFECT OF REQUEST OF GOVERNOR OF BANK OF CANADA

Hon. Robert L. Stanfield (Leader of the Opposition): Mr. Speaker, is the Minister of Finance in a position to say whether his hopes and those of the Governor of the Bank of Canada have been realized in regard to the restriction placed upon the banks in respect of swap arrangements? Has it had the effect of adequately controlling the outflow of capital from Canada?

Hon. E. J. Benson (Minister of Finance): Mr. Speaker, I shall not know the results of the request of the Governor of the Bank of Canada until the end of the week when statistics are available. But I am sure the banks and the Governor of the Bank of Canada are anxious to co-operate with the government and indeed all members of the house in doing the best they can to fight inflation in this country and guard our exchange reserves.

REDUCTION OF FORCES IN EUROPE—INQUIRY AS TO CONCLUSION OF CONSULTATIONS

Mr. Andrew Brewin (Greenwood): Mr. Speaker, my question may be directed to either the Prime Minister or the Minister of National Defence. On April 3 the Prime Minister spoke of a planned and phased reduction of the size of Canadian forces in Europe in consultation with our allies. Have the consultations been concluded and can the house expect to receive a detailed statement of what these reductions are to be?
