It therefore passed in the negative.

The order of the day being read, the House according thereto resolved itself into a Committee of the whole House, on the further consideration of supplies to be granted for the public service.

Mr. Speaker left the Chair.

Mr. Agnew took the Chair of the Committee.

Mr. Speaker resumed the Chair.

Mr. Agnew, from the Committee, reported sundry resolutions, which he read in his place, and delivered in at the Clerk's table, where being again severally read were agreed to by the House, and are as follow:

Resolved that there be granted to His Excellency the Lieutenant-Governor, the sum of ± 150 , to be expended by Commissioners to be appointed by His Excellency, in aid of a subscription of ± 349 , for the building of a Church at the mouth of the Madam Keswick river, in the Parish of St. Mary's.

To Moses Pickard, sen. and Jesse Christy, sen. the sum of $\pounds 50$, to enable them to complete a Presbyterian Meeting-House, which they have already raised and enclosed, on the Keswick Ridge, in the County of York, and Parish of Queensbury.

To His Excellency the Lieutenant-Governor or Commander in Chief, the sum of $\pounds 150$, to be applied by Commissioners to be for that purpose appointed, in aid of a subscription of near $\pounds 300$, towards building a Church in the Parish of Springfield, in King's County.

To the Rector, Church Wardens, and Vestry, of the Sackville Church, the sum of ±100, to enable them to finish the Parsonage House.

To His Excellency the Licutenant-Governor or Commander in Chief for the time being, the sum of £100, to be applied by Commissioners to be for that purpose appointed, in aid of a subscription of £150, towards building a Church at Shediac, in the County of Westmorland.

To His Excellency the Lieutenant-Governor or Commander in Chief, the sum of $\pounds 100$, to be by him applied in aid of individual subscription, towards building a Church in the Parish of Westmorland.

To Crookshank & Johnston, the sum of &75, or whatever may be their claim, for bounty on a fishing voyage performed by the schooner Five Sisters, in the year 1817, (the certificates of which were forwarded to the Secretary's Office, but by some accident have been mislaid), provided they produce a certificate from the Custom-House at St. John, of the voyage having been actually performed, and a farther certificate of the same nature attested by them, to be laid before His Excellency the Lieutenant-Governor and the Honourable Council.
