Supply—Fisheries

Soviet union is interested in halibut and undoubtedly, in salmon fisheries on our side of the ocean, could the minister indicate whether he discussed this matter with any of the Soviet officials? Did he gain any impression from talking to them that there was a possibility of their entering the treaty, if they were invited? What are the prospects of putting into effect that which the minister so earnestly embraced in 1962 or 1963?

Mr. Robichaud: I am glad the hon. member has mentioned vote 5. On page 171 of the blue book he will see that \$10,000 was voted last year for the International Council for the Exploration of the Sea, and that this year the figure had been raised to \$20,000 for the full year, the figure for last year being for half a year only.

Yes, I did discuss the North Pacific treaty with the minister of fisheries of the U.S.S.R. He expressed the views of his government. It is not a matter for the government of Canada to invite the U.S.S.R. to participate in the North Pacific treaty. It is a tripartite treaty comprising Japan, the United States and Canada and it would be up to those three countries to invite the U.S.S.R. to participate if it were considered advisable.

I certainly acquired much information from my discussion with officials of the government of the U.S.S.R. and from their minister of fisheries relating to their policy and their position in this regard. I must say that we did not come to any conclusive decision. I expect to bring this matter up again during Mr. Ishkov's visit to Canada, sometime in the next few weeks. Nevertheless I gather that under the present form or application of the North Pacific treaty the U.S.S.R. will not be interested in participating.

Mr. Robichaud: As soon as the regulations were approved we notified the Prince Rupert co-operative and they are free to apply now. I am not sure if their application has been forwarded; it has not been laid on my desk yet. If they do apply I assure the hon. member that they will receive full consideration.
