#### NIGERIA—CANADIAN EFFORTS TO END CIVIL WAR

On the orders of the day:

**Mr. Heath Macquarrie (Queens):** I have a question for the Secretary of State for External Affairs on the war between Nigeria and Biafra. Considering that a member of the Commonwealth is supplying arms to one party in this dispute, can the minister advise whether Canada is taking any initiative within a Commonwealth context to bring to an end this flow of war materials and, hopefully, to the war itself?

**Hon. Paul Martin (Secretary of State for External Affairs):** I indicated on Thursday last, I believe, that the Secretary General of the Commonwealth, with the approval of most Commonwealth countries, was in the

process of mediation, and it was generally felt that his endeavours in this regard ought to be supported.

### NATIONAL DEFENCE

#### NORAD—HOUSE CONSIDERATION OF RENEWAL AGREEMENT

On the orders of the day:

**Mr. Andrew Brewin (Greenwood):** My question is for the Prime Minister. In view of the importance to Canada of current negotiations for the renewal of NORAD will the right hon. gentleman assure the house that the renewal agreement will be submitted for discussion in this house before it is signed?

**Right Hon. L. B. Pearson (Prime Minister):** No, Mr. Speaker, I cannot give that assurance. The government will have to take its responsibilities and then submit its decision to the house, as is normally done in connection with these matters.

#### INQUIRY AS TO PURCHASE OF TRANSPORT AIRCRAFT

**Mr. Lloyd R. Crouse (Queens-Lunenburg):** I have a question for the Minister of National Defence. Is it the intention of the Department of National Defence to proceed with the purchase of four Lockheed C-141 Starlifter transport aircraft?

**Mr. Speaker:** Order. The question ought to be placed on the order paper.

**Mr. Crouse:** May I point out that there is urgency attached to this question, in view of the fact that defence planners have known since 1965 that they would want about a dozen Starlifters to make the army truly mobile and to refuel Canada's new fighters—
