the government to introduce price and wage guidelines as a means of checking inflation and making it possible for hard-pressed firms to compete in the United States and world markets? If not, does the government intend to introduce some better method of controlling inflation?

Right Hon. P. E. Trudeau (Prime Minister): Mr. Speaker, I have said before, and I repeat now, that we are considering this method and keeping it under review, but no decision has been taken to introduce such guidelines.

## UNITED STATES IMPORT SURTAX—RESPONSE TO CANADIAN REQUEST FOR EXEMPTION

Mr. David Lewis (York South): Mr. Speaker, I want to direct my question to the Minister of Finance. It arises out of reports contained in both his speech yesterday and that of the Minister of Industry, Trade and Commerce. In the discussions in Washington did the United States administration definitely refuse to exempt Canada from the 10 per cent surtax, or was there an undertaking to consider the request with an answer to be given at a later date?

Hon. E. J. Benson (Minister of Finance): The latter is the case, Mr. Speaker.

**Mr.** Lewis: If the latter is the case, would the Minister of Finance inform the House whether he has received any indication when a reply, either yes or no, to his request may be given?

**Mr. Benson:** No, Mr. Speaker. Talks have been continuing, as I mentioned in my speech yesterday, at the official level, and it has been agreed that there will be further talks in the near future.

**Mr. Lewis:** During the talks either among the ministers or among the officials have any requests or suggestions been made by the United States authorities that Canada should make concessions in any particular direction in order to obtain the exemption asked for?

Mr. Benson: Certainly not to my knowledge, Mr. Speaker.

Hon. Robert L. Stanfield (Leader of the Opposition): I have a supplementary question, Mr. Speaker, with regard to the speech of the minister. Would the Minister of Finance inform the House which side of the House he was threatening when he said he would probably run again, or was he threatening the unemployed?
