and the provinces instead of this arbitrary and unfair action being taken.

Mr. Nystrom: Mr. Chairman, I am always about to forgo asking any questions until I hear the Liberal backbenchers heckling. We can facilitate the passage of this bill if the committee will only listen for a moment or two. I wish to ask the minister one or two questions. I think I know the answers. However, I want to be very clear and to have this on the record.

In Saskatchewan there is the Saskatchewan Power Corporation. It is a publicly owned utility that provides electricity to the people of Saskatchewan. It purchases gas at the lowest possible price and sells to the consumers in the province at the lowest possible price. It is trying to give a service to the people of Saskatchewan.

Is there any way the minister can interpret this legislation to say that the Saskatchewan Power Corporation is not selling gas to the Saskatchewan consumer at a high enough price, or is not selling it at the fair market value? It buys the gas at low cost and sells it to Saskatchewan consumers at low cost. That might be below the fair market value on the free market under this legislation. Would the gas the Saskatchewan Power Corporation purchased be deemed to have been purchased at a higher price than the price for which the Corporation was selling it?
