3. In each case, did they receive a daily food or meal allowance and, if so, what was the (a) amount per day (b) total amount?

4. What were the reasons they were brought to Ottawa and was personnel not available in Ottawa with sufficient qualifications to fill the particular positions?

5. Were any Programme Officers with LIP or any other persons working with LIP in Ottawa relieved of their duties during this period of time in order to make way for the three employees from Montreal and, if so, what were the reasons justifying such a step?

6. Before being transferred to Ottawa did any of the three employees challenge or disobey directives from LIP Headquarters in Ottawa and, if so, to what extent?

(i) Until suitable single bedroom apartments could be found, the three employees stayed at the Carleton Towers Hotel, with the exception of July 29, 30, 31, 1975, when A. Aubry used the Park Lane Hotel. (ii) A. Aubry, hotel \$526.11, apartment \$2,661.24; J. Brunet, hotel \$894.72, apartment \$2,661.24; (Calculations to December 19/75); C. Peloffy-Dostie, hotel \$410.08, apartment \$900. (Calculations to October 31/75).

3. Yes. (a) The meal allowance paid each employee was \$12.45 daily up to September 30, 1975. This rate became \$13.25 on October 1, 1975. (b) A. Aubry, \$1,736.90 (Calculations to December 19/75); J. Brunet, \$1,804.25 (Calculations to December 19/75); C. Peloffy-Dostie, \$765.75 (Calculations to October 31/75).

4. At the inception of the 1975-76 Local Initiatives Program there was a need for additional staff to deal with an increased work load at the National Office. In view of the immediate need to fill these positions, three experienced

employees from the Quebec Provincial Office who were knowledgeable about the Program and the Quebec region were assigned to these duties on a temporary basis during the peak period of operation of the LIP Program until such time as the positions could be filled through regular staffing action. In addition to meeting an immediate requirement, the Department believed it would be advantageous for Regional staff to obtain Headquarters experience. The remaining officers will complete their assignment on January 30th, 1976.
