REQUEST THAT LEGISLATION BE AMENDED

Mr. Steven W. Langdon (Essex-Windsor): Mr. Speaker, my question is directed to the Minister of State for Finance. It is not her responsibility that we have a tax system which is riddled with loopholes for large corporations to make these rip-offs of the ordinary taxpayer. But is the Minister prepared here in the House today to make a commitment to the Canadian people that this kind of escape hatch for large corporations and wealthy people will be closed, in order to prevent this kind of thing in the future?

Mr. Steven W. Langdon (Essex-Windsor): Let me ask the Minister again if she really believes that the continued existence of this kind of law, which permits \$1 billion in tax revenue to escape from the Canadian people, makes sense to the ordinary person in this country? Or is it not simply a rip-off for the corporate sector which is impossible to justify?

Hon. Barbara McDougall (Minister of State (Finance)): Mr. Speaker, what I believe is that this Government is committed to creating jobs. We have done that and will continue to do so throughout the economic and financial policies we have introduced. I think that that is what the Canadian people want from us. They want jobs and they want growth.
