### TRADE

CANADA-UNITED STATES NEGOTIATIONS—FUTURE OF AUTO PACT

Mr. Steven W. Langdon (Essex—Windsor): Mr. Speaker, my question is directed to the Minister for International Trade. How can she say that the Auto Pact is not on the table when we have seen the pressure applied by the Governor of Michigan? I now have a letter here from the Governor of Wisconsin making precisely the same points and stressing that the Auto Pact "leans heavily in favour of Canada and the U.S. must improve this imbalance in the free trade talks". Why is the Government trying to con the people of Canada?

Hon. Pat Carney (Minister for International Trade): Mr. Speaker, I thought I had made it clear that the reason I can

say the Auto Pact is not on the table is because it is not on the table. The negotiators are meeting now and I am advised by them that the Auto Pact is not being discussed. The Auto Pact has not been discussed. As I said, we do not propose to put it on the table. If the Americans want to do so, we will look at their proposals. If they are good for employment, production and investment in Canada, we will look at them.

The only people who are trying to put the Auto Pact on the table are the opposition Members. They are putting thousands of jobs and billions of dollars in investment on the table with these red herring scare tactics.

Mr. Langdon: The Minister knows perfectly well that Mr. Merkin heads a working group on automotive products which is dealing with precisely this issue. A memo that reports his statements is bound to have much more truth in it than anything the Minister says.
