FINANCE-FIRST REPORT OF STANDING COMMITTEE

#### [Translation]

The Finance Committee therefore recommends:

1. That the Bank of Canada moderate its monetary policy and not resist downward market pressure on interest rates, whatever the consequences for the value of the Canadian dollar abroad.

2. That the Government consider the advisability of relying less on short-term debt by considerably modifying its debt structure in favour of the longer term, as market conditions permit.
