#### REGISTRATION OF LOBBYISTS

COMPREHENSIVE REVIEW OF ACT

BILL C-91

Mr. Nelson A. Riis (Kamloops): Mr. Speaker, it is my honour to present a petition, pursuant to Standing Order 36, on behalf of a number of constituents.

They point out that Bill C-91, which is before the House at the moment, will allow brand name drug companies to market their drugs without any competition from the generic drug companies for up to 20 years. They say that this will increase the prices that provincial and private drug plans have to pay.

The petitioners are asking that we not proceed with Bill C-91. As well they suggest we repeal Bill C-22 which was passed in 1987. This would enable Canadians to have full benefit from lower priced generic drugs, allowing substantial savings to occur to provincial drug plans.
