GIRL MUST CHOOSE
ACTOR OR FORTUNE

Catherine Bigelow, Now
Twelve, Has Much Money
Left to Her Conditionally

New York, Sept. 22.—"I desire that my
granddaughter, Catherine Bradley Big-
elow, shall at no time marry a divorced
man or actor, and in case this provision
of my will shall be broken she shall forfeit
her interest in my estate, both real
and personal, and the same shall go to
my son and daughter, Forbes Hennessey
and Ellen Mary Parker, respectively."
Ellen M. Hennessey, widow of former
Fire Commissioner James S. Hennessey,
made this provision in her will, which
has been filed with the surrogate. Viola-
tion of the clause by the grandchild, who
is now under twelve years of age, will
mean that she will lose one-third interest
in the estate, which is valued at more
than \$500,000.

Mrs. Hennessey made careful provision
for the rearing of the child. Francis Xavier
of the will she stipulates that a maid
or chaperon of refinement and edu-
cation shall be provided for the girl.

Principal When 25

Until Catherine is twenty-five years of
age the money will be held in trust by the
executors of the will. They are to apply
\$1,000 yearly for her support and edu-
cation until she is twenty-one, and \$1,200
until she is fifteen; \$2,000 yearly from
the age of twenty-one until she is twenty-
five. If she has not wedded an actor or a
divorced man by that time she will receive
the principal.

The residue of Mrs. Hennessey's estate
is divided equally between her son, Forbes
Hennessey; her daughter, Ellen Mary
Parker, and her grandchild, Catherine
Bigelow. She makes her son, daughter
and grandchild executor, and provides
that the cost of any bequest shall
annul the same.

The largest charitable bequests are
\$1,000 to the College of St. Francis Xavier
for the "Catherine Bradley scholar-
ship"; \$1,000 to the Church of St. Francis
Xavier; \$200 to the pastor of the Church
of St. Ann; \$200 to St. Francis Hospital;
\$250 to the Society of St. Vincent de
Paul; \$200 to the pastor of the Church
of St. Francis Xavier's Church for the
repose of the soul of the testatrix;
\$100 to the pastor of the Church of
St. Francis Xavier's Church for the
repose of the souls of the testatrix's
father, mother, husband and brother;
\$50 to St. Patrick's Church.

The cook and coachman are left \$100
apiece. The articles of furniture and
accessories in the Hennessey home at No.
117 East Eighteenth street, are bequeath-
ed to the immediate family of the tes-
tatrix.

THRILLING TALE OF
SEA IN THE CROSBY'S
EXPERIENCE

The schooner Henry Crosby, which is
owned in Bangor and vicinity, is now at
St. John, N. B., where she will be in-
spected by Capt. Heenan, the master, and re-
paired if he thinks practicable. The
Crosby was dismantled in a hurricane about
a month ago, and all her masts and crew
were torn away. After a thrilling
voyage under jury masts she was met a
few days ago about 50 miles off Mobile
and towed to port.

The story of the disaster to the Crosby
is a most interesting one, and the crew
of the New York Sun gives some idea of
the hardships which the crew were forced
to undergo.

"The dismantled three-masted schooner
Henry Crosby, was towed into Mobile,
having been picked up off Mobile bay
without provisions or crew, by the
Florida liner Manteo. The schooner was wrecked
in the hurricane of Aug. 24.

"The bringing of the vessel 700 miles
under jury masts is considered a remark-
able feat, doing credit to C. M. Crooks,
the master of the vessel, and his crew
of seven men. The Crosby ran into the
West India hurricane 150 miles northeast of
Xavier."

The storm continued with such force
that in order to save the vessel from total
destruction the three masts were cut
away. When the weather subsided jury
masts were rigged with booms, and with
the sail that was left the course was fixed
toward Mobile. The Crosby made the
entire trip under the jury rig and would
have come into port under that sail if the
provisions and water had not run out on
Saturday night. The Crosby sighted the
Mainland early Sunday morning and ar-
rangements were made with the captain
to tow her in.

The Crosby sailed from Mobile on June
30 for San Juan, Porto Rico, with a car-
go of lumber and was unloaded and sailed
again on August 13 and was out but a
short time when the hurricane struck her.
Eight days after the storm struck the
vessel an offer of \$2,000 to tow the vessel
was made by a passing steamer, but it was
refused. E. & L. K. Stetson of Bangor
are agents for the schooner.

once deputed to call upon the minister
of public works when he arrives in the
city next week.

LABOR MEN CRITICIZE
RAILWAY COMPANY

Lebanon, N. H., Sept. 23.—Resolutions
strong in condemnation of the policy of
the Boston & Maine R. R. were passed
yesterday at the second day's session of
the eighth annual convention of the New
Hampshire State Federation of Labor.

Following a discussion of the accident of
yesterday at Pater, in which several were
killed, the following resolution was passed:
"Resolved: That the sympathy of this
convention be extended to the families
and relatives of those who lost their lives
or were injured in the railroad accident
at Pater. We condemn the negligent and
pernicious policy of the Boston & Maine
R. R. in continuing the use of old and
antiquated cars, and we further condemn
the management for its heartlessness in
compelling train dispatchers, telegraph
operators and trainmen to work long hours
for small wages, and we strongly urge our
state authorities to make a rigid investi-
gation of this accident that the traveling
public may not be sacrificed to the greed
of the Boston & Maine R. R."

PEARY SNAPSHOTS AND
WAR SHOW AT NICKEL

Tonight at the Nickel some snapshots
of Commander R. E. Peary, the North
Pole discoverer, his wife's family and

REFUSES LOAN TO SAVE
WIFE FROM PRISON

Cleveland, O., Sept. 22.—Rather than
lend his former wife \$500, which would
have kept her from going to prison Jacob
Fickel, a brewer, saw her sentenced to the
