1. Bill further to amend and to consolidate, as amended the several Acts respecting the Public Lands of the Dominion therein mentioned (Sir John Macdonald); Ordered; Presented, 161. Read a second time; Committed; Progress reported, 274. Order for House again in Committee discharged and Bill withdrawn, 490.
2. Motion by Mr. Blake, That the present system of administering the Dominion Lands situate along the lines of Railway is likely to result, practically, in the acquisition by the Railway Companies of almost all the enhanced value, not merely of their own lands, but also of the Dominion Lands in immediate proximity to Stations on such Railways; and that steps should be taken with a view to secure to the public, as far as practicable, such enhanced value in cases of Stations hereafter to be established; Withdrawn, 354.
