AIRPORTS

REQUEST FOR STATEMENT ON POSITION AT HALIFAX

On the orders of the day:

Mr. S. R. Balcom (Halifax): I wish to inquire of the Minister of Transport whether or not he is in a position to make a statement concerning the airport at Halifax, outlining the progress made to date, along with information which might indicate the probable date of starting operations.

Hon. Lionel Chevrier (Minister of Transport): I do not know that I can give a complete statement answering the hon. member, Mr. Speaker, but I may say this. We are desirous of building an airport at Halifax. As the hon. member knows, we have made surveys in the Lucasville area which indicated that weather conditions there were not better than those which prevailed at Halifax. Since then we have had a further survey made of the Kelly lake area near

Halifax. This has been completed and an analysis of that survey indicates the Kelly lake area warrants further investigation on the ground.

To this end the department will send a survey party as soon as it is possible so to do in order to complete that investigation. For that reason it is not possible for me to say at this time when the construction will begin, other than to say that if reports in the Kelly lake area prove satisfactory, and subject to the city of Halifax providing the lands for airport facilities, then we will proceed with the construction of civil aviation facilities at Halifax.

NATIONAL DEFENCE

RADAR DEFENCES—RELEASE OF INFORMATION TO PUBLIC

On the orders of the day:

Mr. E. D. Fulton (Kamloops): I should like to ask the Minister of National Defence a question about radar installations because it is important for this country to know whether there has been a breakdown of security in his own department. Can the minister tell us how he reconciles his statement of yesterday that the giving of names and locations of government stations is permissible, with the statement made last year that such information would be most valuable to the only potential enemy we have.

Hon. Brooke Claxton (Minister of National Defence): I thought I made the position quite clear yesterday that the publication in the Roundel of individual names of men posted to radar stations was made contrary to security provisions laid down by the chief of the air staff and generally in effect throughout the armed forces. This was done through inadvertence of the editor.

INQUIRY AS TO CLEARING OF ELEVATORS
AT SEABOARD PORTS
