Mr. Jean-Charles Cantin (Parliamentary Secretary to Minister of Trade and Commerce): The actual expenditures of the Canadian Government Travel Bureau for the past nine years are as indicated below. The figure provided for 1966-67 is the estimated expenditure for the current fiscal year. 1957-58, \$1,930,766; 1958-59, \$2,206,129; 1959-60, \$2,-299,939; 1960-61, \$2,682,516; 1961-62, \$2,974,-851; 1962-63, \$3,341,428; 1963-64, \$3,868,359; 1964-65, \$4,908,713; 1965-66, \$6,332,549; 1966-67, \$10,070,000 (Estimated—including \$1.4 million for Centennial advertising).
