- (6) Cultural Events: Information concerning a programme of cultural events organized once a month by a particular ethnic group; relationship of this program to the general social organization program aimed at ethnic minorities in North Western Quebec.
- (ii) I am informed by the Company of Young Canadians that volunteers of the CYC are involved with the communities in producing the television program "Le Bloc". The volunteers are: Stéphane Cloutier, André Dudemaine, Jean Ouellet, Pierrette Cloutier, Michel Lemieux, and Marcel-Yves Bégin. The regional office of the Company of Young Canadians is located at 185, Principale, Rouyn, P.Q.
- (iii) Volunteers of the Company of Young Canadians receive an allowance in accordance with CYC policy, in amounts of \$270 per month for a single volunteer or \$370 per month for a volunteer with dependents, for the duration of their two year contract.
