REACTION TO MINISTER'S OFFER TO BROADEN TERMS OF REFERENCE OF INQUIRY INTO USE OF BILINGUAL AIR TRAFFIC CONTROLLERS

Mr. Donald W. Munro (Esquimalt-Saanich): Mr. Speaker, my question is directed to the Minister of Transport and refers to a question of yesterday. In view of the positive response last evening of the spokesman for the air traffic controllers welcoming the minister's offer to broaden the terms of reference of the public commissioner, has the minister approached the commissioner or the interested parties to see whether such action on his part would facilitate solutions to the outstanding issues, or was his offer just a gesture?

Hon. Otto E. Lang (Minister of Transport): Mr. Speaker, I am sure the hon. member does not mean to add that kind of final phrase, and I would be glad if he would refrain from doing it.

Mr. Munro (Esquimalt-Saanich): Mr. Speaker, will the minister be taking steps this afternoon when he does meet the Commissioner to extend the time so that all parties directly concerned may reach a solution, especially in light of the complexity of developing satisfactory procedures for IFR through the simulator which, by some accounts, has not yet been activated and made operational?

REQUEST FOR REPORT ON INVESTIGATION OF ALLEGED FRAUD—POSSIBILITY OF CHARGES

Mr. Tom Cossitt (Leeds): Mr. Speaker, my supplementary is directed to the Minister of Manpower and Immigration. Is the minister in a position to provide the House with full details of the investigation carried on by his officials in co-operation with the Royal Canadian Mounted Police into the extensive defrauding of the Unemployment Insurance Commission, particularly in Ottawa, and can he tell the House when charges will be laid against all those involved in addition to those laid against Gordon Gun of Ottawa.

Hon. Robert K. Andras (Minister of Manpower and Immigration): Mr. Speaker, I can only indicate to the hon. member, as he pointed out, that this matter is under investigation by the Royal Canadian Mounted Police. Until they have completed their investigation I think it would be a disservice for me to make any detailed comment. Charges, if they are warranted, will be laid. We will encourage that course if that is the case, but we have to await their investigation.

NUMBER OF OUTSIDE EXPERTS RETAINED TO HELP PREPARE BUDGET—MAINTENANCE OF BUDGET SECRECY
