Hon. Gildas L. Molgat (Deputy Leader of the Opposition): Honourable senators, yesterday our colleague, Senator Lavoie-Roux, praised athletes and their coaches who represented Canada at the Olympic Games in Albertville, and that praise was well deserved.

My point is to demonstrate how important it is to maintain the funding for an organization that provides the ultimate in training for young people in this country, and to stress the tangible results of the work done by the cadet corps. I have nothing but praise for all those who participate or have participated on the military side and for all young people who belong to the Canadian cadet organization, and I again wish to congratulate Miss Bédard on her success.
