

## NOTICES OF MOTIONS AND QUESTIONS

*Mr. Veniot*—On Wednesday next—INQUIRY OF MINISTRY—1. How much of the following resources of Canada, in raw or semi-raw state, was exported during the calendar years 1929 and 1930: asbestos, nickel, pulp wood, pulp, iron ore, silver, gold and zinc?

2. How much of above resources was exported in raw or semi-raw state during the calendar years 1931, 1932 and 1933?

*Mr. Blair*—On Wednesday next—INQUIRY OF MINISTRY—1. What sums were paid for legal fees, and for what services rendered to any Department of the Government since September, 1927, to the firm of Kilmer Irving and Davis of Toronto?

2. Who are now, or were the members of the firm during that time?

3. What other law firms of lawyers resident in Ontario have received fees from the Dominion Government, and in what amounts, since 1927?

*Mr. Blair*—On Wednesday next—INQUIRY OF MINISTRY—1. What were the quantities of butter exported to Canada during years 1930, 1931, 1932, and 1933, by: (a) New Zealand, (b) Australia?

2. What were the prices of the butter each month during the above-mentioned years at the Canadian ports of entry?

3. What were the duties, dumping penalty or other taxation, imposed per pound each month of the above periods?

*Mr. Blair*—On Wednesday next—INQUIRY OF MINISTRY—1. Who are the members of the Trent Canal staff?

2. What are their respective positions and salaries?

3. When were they appointed?

4. How many are engineers?

5. What members of the staff are furnished with, (a) rent-free house; (b) rent-free telephone; (c) fuel and light without charge?

*Mr. Blair*—On Wednesday next—INQUIRY OF MINISTRY—1. What tonnage carrying freight passed through the Trent Canal from Lake Ontario to Georgian Bay during each of the years 1929 to 1933 inclusive?

2. What tonnage of other craft passed over this route during each of the same years?

3. What has been the total costs of the Trent Canal detailed as follows: (a) constructions costs, repairs and betterments; (b) salaries of staffs; (c) settlement of drowned lands claims and costs of lands expropriated or purchased?

*Mr. Blair*—On Wednesday next—INQUIRY OF MINISTRY—1. What income from the Trent Canal has the Federal Government received during years 1929 to 1933 respectively, as follows: (a) rentals of property; (b) rentals or dues from power users; (c) tolls?

2. What was the expenditure upon Trent Canal during 1932 and 1933 for, (a) salaries and wages; (b) construction and repairs; (c) all other expenditures?

*Mr. Blair*—On Wednesday next—INQUIRY OF MINISTRY—What share has the Federal Government agreed or offered to agree to assume of construction of new bridge to replace Locks Bridge on King's Highway at Peterborough?
