

*Pistoles*—Additional amount required, \$1,000; *Les Eboulements*, \$2,200; *Ste. Anne de Sorel*, \$1,200; *Longue Pointe* and *Boucherville Ferry*, \$500; *Ste. Anne de Bellevue* \$4,750; *River Ottawa*—Removal of a shoal opposite the line between the Townships of *Bristol* and *Clarendon*, \$3,000, for the year ending 30th June, 1885.

19. *Resolved*, That a sum not exceeding Forty-nine thousand dollars be granted to Her Majesty, to defray the following expenses in connection with Harbours and Rivers, *Ontario*, viz.:—*Port Albert*, \$1,000; *Lion's Head*, *Lake Huron*, \$5,000; *Bayfield*, *Lake Huron*, \$4,000; *Wilson's Channel*, \$5,000; *Sault Ste. Marie*, \$4,000; *Cobourg*, *Lake Ontario*, \$10,000; *River Ottawa*—Improvement of channel, Upper to Lower *Narrows*, above *Pembroke*, \$2,000; *Thornbury*, *Lake Huron*, \$1,000; *River Sydenham*, \$2,500; *Little Bear Creek*, \$2,500; *Kincardine*, *Lake Huron*, \$3,000; *Kingsville*, *Lake Erie*, \$4,000; *River Ottawa*—Projected improvements between *Mattawan* and *Lake Temiskaming* (examination), \$5,000, for the year ending 30th June, 1885.

20. *Resolved*, That a sum not exceeding Ten thousand dollars be granted to Her Majesty, to defray expenses in connection with *Waterhen River*, *Manitoba*, for the year ending 30th June, 1885.

21. *Resolved*, That a sum not exceeding Ten thousand dollars be granted to Her Majesty, to defray expenses in connection with *Saskatchewan River*, *North-West Territories*, for the year ending 30th June, 1885.

22. *Resolved*, That a sum not exceeding Nine thousand one hundred and fifty dollars be granted to Her Majesty, to defray the following expenses in connection with Harbours and Rivers, *British Columbia*:—*Serpentine River*, \$1,000; *Cowichan* and *Courtney Rivers*, \$650; *Victoria Harbour*, \$2,500; *Fraser River*, *Cottonwood Canyon*, \$5,000, for the year ending 30th June, 1885.

23. *Resolved*, That a sum not exceeding Seven thousand dollars be granted to Her Majesty, to pay the following expenses in connection with Dredging, *British Columbia*:—Additional amount required for dredging, \$3,000; Additional amount required for working Snag Boat, \$4,000, for the year ending 30th June, 1885.

24. *Resolved*, That a sum not exceeding Eleven thousand dollars be granted to Her Majesty, to defray the following items in connection with Slides and Booms, viz.:—*River Morasse*, \$1,000; *Ottawa District*, \$10,000, for the year ending 30th June, 1885.

25. *Resolved*, That a sum not exceeding Twenty-two thousand five hundred dollars be granted to Her Majesty, to defray the following expenses in connection with Roads and Bridges, viz.:—Aid towards the construction of a free Bridge over the *Old Man's River* at *Fort Macleod* (Local authorities furnishing \$2,500), \$2,500; Bridge across the *Battle River* at *Battleford*, \$5,000; *Portage du Fort Bridge*—Repairs, \$5,000; Aid to municipality of *Russell*, *Manitoba*, towards the construction of a Bridge across the *Assiniboine*, near the mouth of *Shell River* (Revote), \$10,000, for the year ending 30th June, 1885.

26. *Resolved*, That a sum not exceeding Four thousand dollars be granted to Her Majesty, to pay for services performed by persons in the Customs and Marine and Fisheries Departments, and other expenses in connection with the distribution of the Fishing Bounty and collection of Statistics, for the year ending 30th June, 1885.

27. *Resolved*, That a sum not exceeding Two hundred dollars be granted to Her Majesty, to pay gratuity to the family of the late *Henry Gray*, lost on the "*Princess Louise*," for the year ending 30th June, 1885.

28. *Resolved*, That a sum not exceeding Five thousand dollars be granted to Her Majesty, to pay legal and other expenses in connection with the *Ontario Boundary Question*, for the year ending 30th June, 1885.

29. *Resolved*, That a sum not exceeding Three thousand dollars be granted to Her Majesty, to pay one-third cost of Mail Service in the *North-West Territories*, for the year ending 30th June, 1885.

30. *Resolved*, That a sum not exceeding Two hundred dollars be granted to Her Majesty, to pay Legal Adviser, for the year ending 30th June, 1885.
