MARINE NOTES.

The Nova Scotia Legislature has passed a resolution, urging the Dominion Government to grant a tonnage bonus of \$6 per ton to encourage the establishment of steel shipbuilding. The resolution passed unanimously.

King Edward's new turbine yacht "Alexandra," of 2,000 tons, was launched at Glasgow on May 30th, and was christened by Princess Louise, the Duchess of Argyll.

Westville has decided, by a good majority, to authorize the Town Council to borrow a sum, not exceeding ten thousand dollars, for extension of the water-works.

Engineers of the Department of Railways and Canals are now preparing specifications preparatory to calling for tenders for the completion of the southern outlet of the Trent Valley Canal. This summer contracts will be let for a considerable portion of the canal. One stretch starting at Trenton will be begun, and work will also be started at the end of the present completed section near Rice Lake. Engineer Walsh is now making a survey of the suggested northern outlet via Nottawasaga Bay, instead of by the Severn River, as now proposed. As soon as his report is submitted the northern outlet will promptly and finally be decided upon, and the completion of the whole canal pushed with all possible speed.
