Shots were fired at him, but he escaped unhurt. The New Jersey Central Withdraws From the Centern.

TRENTON, N. J., Jan. 9.—The great Reading coal combine is broken. The New Jersey Central Railroad Company has withdrawn from it, and hereafter will be operated independently, the same as it was before the agreement with the Reading and Lehigh Valley was entered into. The authorities here decline to speak about the matter, but an official of the Central this afternoon confirmed the truth of the news. He said that Attorney Stockton was in possession of a communication from the Central in which it is acknowledged that all its agreements with the roads in question are cancelled and terminated.

THE PORT STANLEY LEASE.

What a Cleveland Paper Says About It.

The Company Has a Capital of \$250,000 -A Margin of \$1 a Ton on Coal-The Capacity of the Ferries.

The Cleveland Leader of the 8th has the following to say of the lease of the London and Port Stanley Railway to capitalists of

that city:

"The company to operate the road will be incorporated at an early date under the Dominion statutes by special act of Parliament. It will be known as the Cleveland, Port Stanley and London Rail and Transportation Company, with a capital stock of \$250,000. The personal and official roster of the company have been kept in the background thus far, but it is learned that the Pennsylvania Company and the Ohio and Pennsylvania Company and the Ohio and Pennsylvania Coal Company hold large financial interests. Two of the Cleveland gentlemen interested are Mr. Frank S. Miller, who is at present engaged in the real estate and insurance Susiness, and Mr. C. R. Jones, the vessel broker and owner. They have acted for the other stockholders all through the progress of the deal in arranging the preliminaries, and will be active in the management of the new enterprise. that city:

""One of the principal sources of revenue of the railroad and transportation company is the immense field that is opened up for the sale of coal. The directness of transportation from the mines will give the companies patronizing this line a margin of nearly \$1 per ton under the cost of hauling it around by way of Bufalo or Detroit. They can'afford, therefore, to make better prices to the retailers and consumers than have heretofore obtained, and the result is that already a contract has been closed with a Canadian company for the sale of 400,000 tons of coal, the delivery to extend over four years. All, or the greater part, of the coal will be shipped through Cleveland. This will give the lake commerce of this port a tremendous increase for 1893 in this one commodity, as compared with 1892. Besides this, the passenger business across the lake, while it has never been given a fair test, will, it is anticipated, afford plenty of business for one or two good steamers, which it is the design of the company to purchase at an early date, options having already been secured. The saving in time and money as against the old route stands in favor, and while little will be done in the one-day excursion line, yet it is thought by advertising Port Stan-

old route stands in favor, and while little will be done in the one-day excursion line, yet it is thought by advertising Port Stanley as a summer resort through Cleveland territory, a large excursion business will be worked up.

"Further significance is lent to the above deal by the information that the Ohio and Pennsylvania Coal Company has just purchased from the Grand Trunk Railway, of Canada, the two large car ferries Huron and International. These boats have plied across the St. Clair River, between Port Huron and Sarnis, for several years past, being engaged in the transportation of cars and international. Incree boats nave piled across the St. Clair River, between Port Huron and Sarnia, for several years past, to being engaged in the transportation of cars as a part of the Grand Trunk Railway. Since that company has completed its great tunnel under the river at Sarnia, the car ferries have been of little use to that corporation. They have been kept at work, however, and are in fine condition. New boilers were put in only a few years ago, and about the only thing they need in the line of repairs is heavier work in the shape of shoes, etc., to better adapt them for work in the open lake. It is designed to have them ply between this port and Port Stanley. They have a capacity of twenty 25-ton coal cars each, to ra larger number of box cars. An adjustable switch track is to be put in at the head of one of the slips in the old river bed, and the cars will be run upon the ferry, a few minutes only being required to load. A similar arrangement of tracks will be placed in the river at Port Stanley, and the boats will make a round trip once a day during the soason of navigation. While a comparatively small cargo is thus carried, there is a large saving in handling, and prompe dispatch in port over the old plan of transportation in bulk, and the coal is delivered in as good or better shape than by the all-rail route, not being broken up in transit. WHAT IS PROTESTANTISM?

Address in the Week of Prayer Meet ings by Rev. James Ballantyne. In speaking on the topic for Wednesday of the week of universal prayer, viz., "Nations, and Their Rulers," Mr. Ballan-

tyne said:
"I observe that the Evangelical Alliance has specially suggested 'Prayer that class and race antipathies and persecutions may and race antipathies and persecutions may cease." It is a suggestion that is surely in harmony with the will of Him who said. "A new commandment I give unto you, that ye love one another." This command was a new thing in the world when Christ first uttered it. The Jew loved none but Jews, and what the Gentile thought of others we may gather from the well-known words of one of their wisest, who thanked heaven that he was born a Greek and not a barbarian, a man and not a brute. For

words of one of their wisest, who thanked heaven that he was born a Greek and not a barbarian, a man and not a brute. For eighteen centuries the Church of Christ has been endeavoring to learn the meaning of this commandment, and yet it seems that there are some—some even in our own city calling themselves Protestants—whom it is still a new thing. There has been introduced into this community a spirit the very opposite of that "love which is the fulfilling of the law."

And that my meaning may not be misunderstood, let me distinctly say that I refer to an organization known as the Protestant Protective Association. What I know of its aims has been obtained from those who told me they were members and from others who have been solicited to become members. And I have learned that the obligation taken by its members requires them neither to employ nor to support for an elective position any person who is a Roman Catholic. I do not know what them neither to employ nor to support for an elective position any person who is a Roman Catholic. I do not know what stand this society took in the recent elections in this city. My words have no special reference to that contest: the results of the adoption of such a guide for conduct must go infinitely beyond any single event.

Now, as a Protestant minister, I must protest against any such use being made of the term "Protestant." I believe there are no greater fees of eivil and religious liberty than the very men who will band themselves together by an eath lacking, as this is, in the very elements of true Chistian feeling and conduct. Perhaps no individual illustrates more perfectly that the Christian religion is not what these men seem to believe it is than the Apostle Paul. Before he joined himself to the Christians he was their relentless persecutor. After his conversion he held the new truth even more firmly than he had believed the old, and though his countrymen persecuted him he never ceased to love them. It was "his heart's desire and prayer to God for Israel that they might be saved." Paul does not seem to have dreamt of this latest method of fightand prayer to God for Israel that they might be saved." Paul does not seem to have dreamt of this latest method of fighting error. Indeed, there is the sharpest distinction between efforts to save others from beliefs that we think false and the hatred that leads to persecution because they are held. I can conceive of a man ignorantly becoming a member of such an association, but I am at an utter loss to understand how one who has grasped the essentials of Christ's religion, and who knows what this eath is, should commit himself to such principles. His is not the spirit of Christ, but rather that of Mohammed. He believed in God, as doubtless the members of this association do; but God was to him an arbitrary will, ordaining its creatures to heaven or hell, without love or sympathy or interest, and on no grounds of fitness or justice. Mohammed was consistent with his belief, when with the sword in his hand, he slew those who opposed him, and spread desolation over many towns and villages that rejected his creed. But Mohammed's god is not the God of the Bible, and Christian peeple may not copy his split and methods. ""Equal rights for all" is a watchword." bove his ankle. He was a member of the Princess Hockey Club and an expert 18 "Equal rights for all" is a watchword that appeals to every man's sense of justice, but in this there is no justice or equality. What could more completely paralyze missionary effort among Roman Catholics than the cherishing of such a spirit?
