Dublin, Aug. 16.-Eamonn de Valera, arrested under dramatic circumstances at Ennis yesterday when he appeared to deliver a speech in the election campaign, will probably be brought from Limerick, where he is brought from Limerick, where he is imprisoned at present, to Mountjoy jail within the next few days. The public safety act gives the government power to detain him, and it is considered likely that he will be kept in jail until the condition of the country is more peaceful.



"Greasy dirt, weeks and perhaps months old, was seen by the ambas-sador in many corners when he visited the island last December with the result that the place was pervaded by a flat, stale smell, quite distinct from the pungent odor of unwashed

Sir Auckland thinks the staff go used to this odor, but he says for himself that "it took me 36 hours to get rid of the aroma, which flavored everything I ate or drank. "It's just the old game of obstruc tion, as played by the two supreme obstructionists in this year's council," said the mayor today in reference to the action of No. 1 committee yesterday when they appointed Ald. Greer to succeed the mayor on a committee to see the chief of po-lice on the question of the Ison re-

ward.
"Why," continued the mayor, "that question was all settled long ago in the ordinary way. The settlement was left in the mayor's hands. I consulted with the police commission and after knowing their decision, stated that the money would be given to Sergeant O'Connor. You had the story in The Advertiser and both Ald. Greer and Ald. Judd must

have known that quite well.

"As regards the satary question, it was Ald. Judd himself at one of the council meetings who proposed that it be left over until the report of the citizens research institute was rendered. It shows the childishness of this member, that he is so eager to oppose me that he even proposes to veto his own suggestion made before the whole council.

Mayor Aggrieved. The mayor was distinctly ag-grieved at the action of No. 1 com-mittee yesterday and continued with some heat: "If the idea of increasing salaries is all that some aldermen have to think about it is high time they retired from a share in the gov-ernment of the city. The news that the South Brant member had headed a local delegation, which interviewed Premier Ferguson and At-torney-General Nickle in Toronto, and had asked that he be again appointed magistrate for Brantford set the city by the ears yesterday and is the only topic of conversation in Brantford today. When seeh after he meeting, Premier Ferguson said that he was informed that the city council of Brantford was a unit in the move to reinstate the magistrate Your correspondent interviewed thirteen of the sixteen members of the council, the other three, Messrs W. H. Freeborn, W. H. Ballantyne and J. J. Fisher, being out of town. Two members, Alderman J. F. Mc-Cann and E. Cannally and the council of the coun Cann and E. Campbell, came out flatfooted as favoring the reinstatement, while a few did not commit themselves, but the majority are opposed to the move. Aldermen McCann and Campbell, while personally in favor of the idea, both admitted that they did not think that the council as a whole was behind the suggestion. Premier Ferguson also stated that the city is asking to be allowed to pay Mr. Livingstone's salary and that he had promised to take the matter under consideration and to inquire

into it thoroughly. Nearly all the aldermen remarked that the first they had heard of the idea was when they read the papers yesterday Mayor Billo stated that the personnel of the delegation was unknown to him. As for the statements that had been made, that the city council was a unit in asking for his reinstatement, he pointed out that no one had the authority to
