REQUEST FOR STATEMENT ON LEGISLATIVE PROGRAM

On the orders of the day:

Hon. L. B. Pearson (Leader of the Opposition): I should like to ask the Prime Minister a question about the intentions of the government with regard to parliamentary business before the Easter adjournment. More specifically, I should like to ask him what business there is likely to be in addition to the supplementary estimates and the legislation on the order paper. I should also like to ask whether there will be a budget before the Easter adjournment, with provision for normal discussion and action.

Right Hon. J. G. Diefenbaker (Prime Minister): Mr. Speaker, we intend to proceed with the matters now on the order paper. The fourth set of supplementary estimates will require to be dealt with this week. In addition, of course, there is on the order paper a motion to set up a commission on redistribution, a matter that has been of continuing interest for years. I feel sure the house will want to deal with that at the earliest possible date. Then there are some other measures, of which the house will be given notice in due course, over and above those that are already on the order paper.

I do not think I can go further at this time. I only hope that there will be a spirit of co-operation on the part of the opposition and that we will not experience again the delays that took place on the earlier supplementary estimates.

Mr. Pearson: Mr. Speaker, what the Prime Minister has called delays were due to the inability of the government to give us information as to the business of the house. May I ask the Prime Minister if he will deal with my question regarding the possibility of a budget before the Easter adjournment.

Mr. Diefenbaker: Mr. Speaker, that will receive the attention of the house in due course.

ADMINISTRATION OF JUSTICE

SONS OF FREEDOM—MEETING BETWEEN MINISTER
AND KOOTENAY REPRESENTATIVES

Mr. Herridge: I should like to ask a supplementary question. Are the heads and representatives of all the organizations I have mentioned included in the list of the minister's friends with whom he will speak? That is what I am concerned about.

Mr. Fulton: As I say, I am flattered by this attention to my intended movements. I think the hon. member will have gathered that as yet there is no schedule; therefore his question is a little premature.
