*CANNED RED TUNA CAT FOOD

Question No. 959-Mr. Haidasz:

- 1. Has the Minister of Fisheries received any complaints concerning imported canned red tuna
- 2. What is the reported incidence of steatitis in animal pets fed canned red tuna?
- 3. What are the present regulations concerning imported canned red tuna catfood?
- Mr. MacLean (Queens): Yes, three complaints regarding this incident.
- 2. Only one case of steatitis, or fatty degeneration in pets has been reported to the department. I am informed this condition is caused by lack of vitamin E.
- 3. The Meat and Canned Foods Act, under which canned fish is inspected, contemplates food for man only. There are, therefore, no regulations dealing with the inspection of pet food. Canned red tuna, however, is an excellent source of protein, but is not in itself a balanced ration as it is deficient in vitamin E.

Mr. Halpenny: I am informed by the Canadian Broadcasting Corporation that preliminary site studies have been made for a transmitter location, which will accommodate a directional antenna for a proposed new 5000 watt station to broaden radio coverage, including service to the Queen Charlotte islands. This project is one of those on which planning has been suspended for the balance of this fiscal year, as announced by the C.B.C. in September, 1962 with the reduction in the budget for capital expenditures.
