EXPENDITURE OF FUNDS BY CANADA MORTGAGE AND HOUSING CORPORATION IN ONTARIO RIDINGS

Mr. Doug Lewis (Simcoe North): My question is directed to the same Minister. The construction industry has an unemployment rate of 33 per cent. In Ontario it is 29 per cent, and many of the unemployed are young people. Why was 90 per cent of the CMHC funding under the slush fund spent in Liberal ridings? Hon. John Roberts (Minister of Employment and Immigration): Mr. Speaker, I say to the hon. gentleman, as I said repeatedly, the funds were distributed equitably. I would remind the hon. gentlemen opposite who are so concerned about bias and patronage that it was the Leader of the Opposition who said that if he became Prime Minister it will be 15 years before a Liberal got a job, and if he became leader of the Government, it would be 15 years before a Liberal constituency got a project—

Mr. Mulroney: That is false.

Mr. Roberts: —not us on this side of the House; it was the Leader of the Opposition.

Some Hon. Members: Hear, hear!

Mr. Bradley: Mr. Speaker, I think from what we have seen today that it was the Minister's constituents who made the mistake when they gave him a job.

Mr. Bud Bradley (Haldimand-Norfolk): Mr. Speaker, the Minister said numerous times today, and in the past, that the reason Conservative ridings have not received anything under this program is because we have not worked hard enough and have not applied.

colleague, the Hon. Member for Joliette, who said he was aware of the program and believed his colleagues were as well.

Hon. John Roberts (Minister of Employment and Immigration): On the same point of order, Mr. speaker, I was quoting from a Canadian press report which said, and I quote exactly:

But after glancing at the resume of the information provided by Roberts' office, McGrath said it appears the job funds have been divided equitably.

The Hon. Member assures me he did not say that, and of course I accept his word.
