

Order Paper Questions

1. Has Atomic Energy Canada Limited (AECL), Eldorado Nuclear Limited or the Department of Energy, Mines and Resources (EMR) made any financial commitment to a campaign undertaken by the Canadian Nuclear Association to promote the nuclear industry in Canada and, if so, in each case, in what amounts?

2. Have any employees of AECL, Eldorado or EMR (a) participated in the development (b) undertaken the supervision of any aspect of the campaign and, if so, in each case (i) what positions do they occupy in their department or agency (ii) what responsibilities have they assumed in the supervision of the campaign?

Mr. Jim Hawkes (Parliamentary Secretary to Deputy Prime Minister and President of the Privy Council): I am informed by the Department of Energy, Mines and Resources and the Office of Privatization and Regulatory Affairs as follows:

In so far as the Department of Energy, Mines and Resources is concerned: 1. No. 2. (a) & (b) No.

In so far as Atomic Energy of Canada Limited is concerned:

1. As a co-sponsor of the Canadian Nuclear Association's public information program, AECL has committed \$2.5 million (an amount equal to less than one per cent of AECL's operating expenses) for 1987-88 to the program.

2. (a) & (b) Yes. (i) Vice President, Corporate Relations, AECL. (ii) Chairman, Canadian Nuclear Association's Public Affairs Steering Committee.

In so far as Eldorado Nuclear Limited is concerned:

1. Eldorado Nuclear Limited is a co-sponsor of the Canadian Nuclear Association's information program, which is designed to provide Canadians with information about nuclear energy.

For the 1987-88 fiscal year of the program, Eldorado will contribute \$50,000 toward this program. The contribution is from revenue earned in the market-place and does not involve public funds.

2. Eldorado's Director of Corporate Affairs has participated in the development and supervision of the information program, although the company has not and does not intend to second any of its employees to the program.
