That a Special Joint Committee of the Senate and House of Commons be appointed to examine and report upon the White Paper on Immigration tabled in the House of Commons by the Minister of Manpower and Immigration on 14th October, 1966, and tabled in the Senate this day, and also to examine the Reports on immigration matters made to the Government of Canada by Mr. Joseph Sedgwick, Q.C., in 1964 and 1966:

That the following senators be appointed to act on behalf of the Senate on the Special Joint Committee:-Honourable Senators Baird, Cameron, Croll, Desruisseaux, Fournier (Madawaska-Restigouche), Hastings, Hnatyshyn, Langlois, Macnaughton, Nichol, Pearson and Willis;

That the committee have the power to call for persons, papers and records, to examine witnesses, to report from time to time, and to print such papers and evidence from day to day as may be ordered by the committee, and to sit during sittings and adjournments of the Senate; and

That a message be sent to the House of Commons requesting that house to unite with the Senate for the above purpose, and to select, if the House of Commons deem advisable, some of its members to act on the proposed Special Joint Committee.
